REPORT ON OVERSEAS TRAVEL OF UNDER-SECRETARY FLETCHER TABUTEAU: MELBOURNE, AUSTRALIA

- 1 I recommend that Cabinet note this report regarding the travel that I undertook in my capacity as Parliamentary Under-Secretary for Regional Economic Development to Melbourne, Australia from 18 20 January 2019.
- In Melbourne the meeting held with Regional Development Victoria provided an opportunity to discuss, compare and contrast policies of respective governments that aim to enhance regional economic development. Specifically, the meeting met the following objectives:
 - Demonstrated the importance the New Zealand Coalition Government places on regional economic development through the Provincial Growth Fund;
 - Progressed opportunities for further collaboration between Regional Development Victoria and economic development agencies in New Zealand;
 - Reaffirmed the objectives of the Provincial Growth Fund as agreed by Cabinet;
 - Explored opportunities for further collaboration between Regional Development Victoria and the Provincial Development Unit with respect to risk and assurance programmes.
- The meeting held with senior executives from ANZ, including the Director of Project & Export Finance, Senior Manager of Government Relations & Corporate Responsibility and Head of Housing Strategy provided a high level overview of Australian regional economic development from a banking perspective. Specifically, the meeting met the following objectives:

- Demonstrated the importance of collaboration between the public and private sectors in regional economies;
- Progressed opportunities to showcase the Provincial Growth Fund with ANZ customers in regional New Zealand;
- Discussed public infrastructure investment and where applicable the role ANZ is playing in supporting customers to invest in regional Australia
