PROPOSED OVERSEAS TRAVEL: UNDER-SECRETARY FLETCHER TABUTEAU

I seek Cabinet approval to travel to Niue to open the (new) New Zealand chancellery and to lead annual high level talks with the Government of Niue. The Prime Minister's approval has been given in principle.

Travel Objectives

2 The objectives for the travel are:

- Discuss shared security challenges with the Government of Niue;
- Examine New Zealand development projects being implemented in Niue.

Travel

3 I propose to depart Auckland for Niue on Tuesday 23 April and return on Saturday 27 April 2019.

Travelling Party

I propose to be accompanied by a Foreign Affairs Private Secretary in the office of the Minister of Foreign Affairs.

Under-Secretary Responsibilities

I propose that the Minister for Regional Economic Development cover my Regional Economic Development responsibilities, and that Hon Jones also cover my Foreign Affairs responsibilities as Acting Minister of Foreign Affairs. I note that the Deputy Prime Minister will be overseas during the week of 22 April (this will be the subject of a separate travel approval Cabinet paper).

Costs of Travel

The projected costs of the proposed travel for the travelling party are:

Airfares: \$4,000

Accommodation and other expenses: \$3,750

Hospitality and gifts: \$500

Contingency: \$750

Total \$9,000

I recommend that Cabinet note this report on travel to Niue between 22 and 26 April 2019.

Report

- I led a New Zealand delegation to Niue from 22 to 26 April 2019 to support the official opening of the newly constructed New Zealand Chancery, conduct High Level Consultations, attend Niue's ANZAC day service, and co-sign a Statement of Partnership with the Niue Government.

Chancery Opening

On 23 April, I led from the New Zealand side the opening of a new Chancery, which is a visible sign of New Zealand's commitment to its continued presence in Niue, and highlights the strength of our enduring relationship. The importance of our

relationship was highlighted during Prime Minister Jacinda Ardern's visit in March 2018, during which she presided over the turning of the soil for the new Chancery.

5 The opening was well attended by New Zealand and Niue dignitaries (including a number of Niue Cabinet Members) and the ceremony itself (conducted in Te Reo, Niuean and English) was poignant. The Chancery itself, based on the architectural style of a marae, is well designed for the Niue environment.

The commemoration was moving and acknowledged the important contribution made by Niue in World War One and World War Two.

Statement of Partnership signing ceremony

9 The Statement of Partnership sets out the principles and priorities under which the Government of Niue and the Government of New Zealand will cooperate, coordinate, and partner in identified priority areas. In this Statement we acknowledge the unique nature and significance of our interdependence and reaffirm the commitments made between our two countries and we note our long, established, and respectful relationship, which is founded upon our special constitutional arrangement and a spirit of close friendship.
