- 2 agreed that he be accompanied by one member of staff;
- **approved** the estimated expenditure of up to \$37,714 for the travel expenses of the 3 Ministerial party, as a charge to Vote: Internal Affairs: Members of the Executive – Travel;
- 4 noted that he will also be accompanied by officials from the Ministry of Foreign Affairs and Trade, whose travel costs will be met by the Ministry;

- owit 1 I seek Cabinet approval to travel to Mexico from 3 to 8 March for a bilateral visit centred around establishing key relationships with the newly elected Mexican administration and promoting trade opportunities for New Zealand.
- 2 The Prime Minister has approved the travel in-principle, and House leave has been approved by the Party Whip.

Purpose of Travel

- The primary purpose of my proposed visit is to establish and develop key 3 relationships at ministerial level with the new Mexican administration headed by President López Obrador. A visit early in the administration will ensure that we develop the high-level relationship and high profile needed to bank on the commercial opportunities presented by CPTPP and reinforce New Zealand's strong interest in concluding a high quality free trade agreement with the Pacific Alliance grouping.
- 4 Proposed bilateral engagements with Mexican ministers will be an opportunity to sell Mexico on the merits of working with New Zealand on areas of common interest. This would include exploring high-level interest in cooperation related to Mexico's agriculture and rural development agenda, including vocational training, livestock emissions, and indigenous economic development. I will also sign a bilateral agricultural cooperation arrangement with Mexico.
- 5 In addition to bilateral meetings I will host a breakfast event with the Mexican Foreign Trade Council along with New Zealand and Mexican companies. This event will formally launch a study examining market opportunities under CPTPP and thereby promote the new commercial opportunities presented by the agreement, particularly New Zealand interest in the food and beverage sector.

I will also travel to Guadalajara, Jalisco where the Food and Beverage Fair 'Expo ANTAD Alimentaria' is taking place. This trip will allow me to meet with agricultural representatives from the Jalisco region which is a key agricultural state in Mexico and is the site of a number of existing and emerging commercial interests for New Zealand business. I will host an event with the CNA (the major Mexican agribusiness federation) alongside the Expo, targeting Mexican buyers for New Zealand's food and beverage and agritech products and exploring opportunities for applying New Zealand systems and technology in the region and other parts of the country.

- 7 I will be accompanied by one staff member. Final costs will be determined once the itinerary is confirmed but the estimated cost of travel for me and my staff member is \$37,714.

- 1 The primary purpose of my visit to Mexico was to establish connections with senior members of the new Mexican administration and, in so doing, reinforce New Zealand's interest in concluding a high-quality Pacific Alliance free trade agreement and agree to a bilateral work programme in areas where interests and policies align. It was also a chance to highlight opportunities in a large new CPTPP market and to help develop the trade and investment relationship

In my meeting with Foreign Secretary Marcelo Ebrard - s6(a) - I was able to secure a political blessing for the concept of a bilateral work programme in areas of shared interest.

meeting was also an opportunity to sign a long-planned agriculture cooperation arrangement which will help to increase New Zealand's currently low profile in the Mexican agriculture sector in comparison with Chile and andExpor some other markets.

- My visit was also an opportunity to promote new commercial opportunities 7 under CPTPP. In a breakfast event co-hosted by the Mexican Business Council for Foreign Trade I delivered a keynote address to an audience of New Zealand and Mexican companies. In addition to highlighting the importance of CPTPP and other plurilateral initiatives as backstops against the possibility of further weakening of the multilateral rules-based system, I introduced an NZTE study on market opportunities under CPTPP.
- In my visit to the state of Jalisco I participated in an event co-hosted by NZTE, 8 the Embassy and the Jalisco Agriculture Council that included four New Zealand agritech companies. I presented to around fifty agriculture and agribusiness stakeholders from Jalisco and surrounding states on the opportunities under CPTPP and the New Zealand technology and innovation story with a particular focus on agriculture. In a bilateral meeting, the Governor of Jalisco highlighted interest in a number of areas where Mexico could tap into New Zealand expertise, including dairy genetics and farming systems, kiwifruit production and honey.
