Proposed Overseas Travel: Hon Damien O'Connor

Portfolio Trade and Export Growth

On 4 November 2019, Cabinet:

- **authorised**, retrospectively, the absence of Hon Damien O'Connor from New Zealand, from 1 to 8 November 2019, to travel to:
 - 1.1 Bangkok, Thailand to represent New Zealand at the final Ministerial-level negotiating meeting of the Regional Comprehensive Economic Partnership, in the margins of the East Asia Summit;
 - 1.2 India for a bilateral visit;
- 2 **noted** that he is being accompanied by one member of staff;
- approved the estimated expenditure of up to \$35,354 for the travel expenses of the Ministerial party, as a charge to Vote: Internal Affairs (Members of the Executive Travel);
- 4 **noted** that he is also being accompanied by officials from the Ministry of Foreign Affairs and Trade, whose travel costs will be met by the Ministry;
- 5 **noted** that in his absence Hon Stuart Nash will act as Minister of Agriculture, Minister for Biosecurity, Minister for Food Safety and Minister for Rural Communities.

- 1 I seek Cabinet approval retrospectively to travel to Bangkok, Thailand, for the RCEP Ministerial and Leaders meetings 1 - 4 November and then onto India for a bilateral visit from 5 - 8 November.
- 2 The Prime Minister has approved the travel in-principle.

Purpose of Travel

Thailand

- The purpose of my travel to Bangkok is to represent New Zealand at the final Ministerial-level negotiating meeting of the Regional Comprehensive Economic Partnership (RCEP), in the margins of the East Asia Summit (EAS) which you will attend.
- At the RCEP Leaders Summit in November 2018, Leaders made a pledge to conclude a "modern, comprehensive, high-quality and mutually beneficial RCEP in 2019." Most of the other fifteen RCEP participants want to substantially conclude negotiations this year and the November meetings will be a watershed moment after 8 years of negotiations.
- In Bangkok, I will meet with Trade Ministers in the lead up to the Leaders Meeting to complete negotiations on any elements of text that are still outstanding. At present, a number of issues in the negotiations remain unresolved and my focus will be on securing commercially meaningful market access in goods, services and investment.

7 Hon David Parker has asked me to attend this meeting in Bangkok to continue to defend New Zealand's interests in the RCEP negotiation, and ensure that a final RCEP agreement delivers meaningful outcomes for New Zealand.

India

- The purpose of my bilateral visit to India is to support the Government's goal of lifting the bilateral relationship with India, s6(a)
 - I will visit India as both Minister of Agriculture and Minister of State for Trade and Export Growth.
- A ministerial visit to India in 2019 is a high priority for both the Ministry of Foreign Affairs and Trade (MFAT) and the Ministry for Primary Industries (MPI). India is an important trading partner our seventh largest export market overall and fourth largest in terms of favourable balance of trade, including trade in goods and services. ^{s6(a)}
- Regardless of whether RCEP substantially concludes at the November Summit, my visit provides an opportunity to continue to advocate for New Zealand's trade interests, including helping to secure political support for any final RCEP deal. \$9(2)(j)
- Beyond RCEP, my visit would enable New Zealand to reinforce our value proposition with respect to the Indian agricultural sector's growth objectives. s6(a)

This would include highlighting the value New Zealand could add to India's agricultural and food processing sectors. Engagement with New Zealand businesses active in the India market would also support these objectives.

- Officials from the Ministry of Foreign Affairs and Trade will also attend this meeting; their travel costs will be met by the departmental budget.
