Explanatory note

This note is not part of the amendment notice but is intended to indicate its general effect.

This amendment notice amends the Russia Sanctions Designation Notices 2022 (the designation notices).

All the above designation notices fulfil the purpose of section 11 of the Russia Sanctions Act 2022, which is to assist users of the regulations made under section 9 to provide further details of who or what is covered by a description in the regulations.

All the above designation notices fulfil the requirement for extension under section 12 of the Russia Sanctions Act, which is that the designation currently identifies persons, assets, or services in a way that is consistent with the description in regulations made under section 9 and is still required for the purpose of the regulations.

Clauses 3 to 16 amend the date on which the designation notices will be revoked. They extend that date from 17 March 2025 to 17 March 2028.

Clauses 5, 14, and 15 replace names of entities in the Annex of each designation notice to the correct name.

Clause 7 amends Russia Sanctions (Alexander Abramov Relatives) Designation Notice 2022 (No 5). It replaces the date of birth of an individual in Annex 1 to the correct date.

Clause 3 and 4 amend Russia Sanctions (State Duma) Designation Notice 2022 (No 7) and Russia Sanctions (Federation Council) Designation Notice 2022 (No 8). They replace paragraph a. in clause 6 of each designation notice to make it consistent with the classes of persons in Part 3 of Schedule 2 of the Act.

Clause 13 amends Russia Sanctions (Irkut Corporation) Designation Notice 2022 (No 12). It replaces "Irkut Corporation" to make it clear that the entity is the same, but the name has been updated to "Yakovlev Corporation (formerly 'Irkut Corporation')".

All clauses come into force on 17 March 2025.
