This Statement of Partnership sets out the shared principles, priorities and understandings that will guide cooperation and engagement between the Government of Aotearoa New Zealand and the Government of Timor-Leste.

In coming together under this partnership, we recognise our shared respect for democratic governance, rule of law, human rights, free trade, and transparency.

We note our long-established bilateral relationship founded on mutual trust, respect and sovereign equality, and governed by the spirit of friendship.

We also acknowledge the enduring principles that guide Aotearoa New Zealand's engagement in Timor-Leste:

Te Puna Manaaki [Fountain of support]: Our engagement will be underpinned by the values of partnership [whakahoahoa], including honesty, trust and respect. We will listen and consult, and act in partnership with principles of participation, predictability and consistency. We will confidently share our views and perspectives with one another, being clear about the things we will do and the things we will not do. The strength of our partnerships empower us to communicate openly even where our views may differ.

Raranga te Muka [Weaving the strands]: Aotearoa New Zealand's global development investments contribute towards global and regional security and prosperity, and to our respective national interests. Aotearoa New Zealand's support helps to address global development challenges and issues that are too big for any country to address on its own. Through this approach we achieve pānga ngātahi [collective impact].

Tātou Tātou [All of us together]: We will collaborate to upscale our ambition and magnify our impact, especially in the Indo-Pacific region where our engagements will contribute to ensuring Timor-Leste and Aotearoa New Zealand's prosperity. Through this approach, we achieve painga takirua [mutual benefit]

Te Pae Tawhiti [A shared horizon]: Our engagement will bring a long-term resilience [pakari] perspective, consistent with our respective enduring interests. We will seek lasting impact through a focus on equitable human development; economic and climate resilience, and kaitiakitanga [stewardship]

This Statement of Partnership builds on the 2016-20 New Zealand – Timor-Leste Joint Commitment for Development and aims to cover all aspects of our partnership, including development, trade, security, foreign policy and people-to-people links.

We acknowledge our collective action on regional and global issues through our commitments to treaties and international instruments, including:

## Enhancing relations through people-to-people links

- Continue to work together to deliver targeted scholarships and tertiary education programmes that enable professional capability development aligned with Timor-Leste's workforce development priorities;
- Foster and deepen the connections created between our peoples and institutions including through Timorese alumni of the Manaaki New Zealand Scholarships Programme;
- Support mutual capacity and capability building relationships through exchanges between Aotearoa New Zealand development volunteers and Timor-Leste communities and institutions (including universities);
- Strengthen and foster people-to-people links and diplomacy through the Asia-New Zealand Foundation;
- Promote parliamentary exchanges, including virtually if required, in particular between women leaders, Members of Parliament and Ministers from Aotearoa New Zealand and Timor-Leste; and
- Promote a deeper understanding and appreciation of cultures and histories through cultural exchanges between indigenous communities, tourism and people-to-people linkages.

- Maintain Status of Forces Agreement (SOFA) between Timor-Leste and Aotearoa New Zealand; and
- Promote connectivity and regional integration by way of an Air Services
   Agreement.
