Defeat ISIS Ministerial

We made a brief (i.e. 36-hour) visit to Washington DC in mid-November to take up the invitation of US Secretary of State Mike Pompeo to attend the Defeat-ISIS Coalition Small Group Ministerial Meeting in Washington.

s6(a) 5 there was a recognition among Coalition members of some significant collective achievements, including most recently the successful operation targeting Abu Bakr al-Baghdadi. There was also a clear recognition of the precarious nature of the situation and the need for Coalition members to keep the pressure on ISIS - both in Iraq/Syria, as well as further afield, especially in West n Attair Africa and the Sahel.

7 On the margins of the Defeat-ISIS meeting, we met with the Foreign Ministers of Turkey, Finland, Denmark and Sweden. The bilateral meeting with Turkish Foreign Minister Mevlüt Cavusoğlu allowed us to maintain friendly relations with a country s6(a); s6(b) s6(a) s6(a)

and Minister Cavusoğlu was warm in his praise of the New Zealand's Government response to the March 15 attacks. The three bilaterals with relatively new Foreign Ministers from Nordic countries allowed us to continue the Government's efforts to strengthen relations with Scandinavia.

Bilateral engagements

We took advantage of being in Washington for the Defeat-ISIS meeting to undertake a number of engagements aimed at promoting the bilateral relationship between New Zealand and the United States. In particular, we had meetings with Secretary of State Pompeo and the recently appointed National Security Adviser Robert O'Brien. Our key bilateral objectives were to reinforce the s6(b) case for the US to be prepared to initiate a FTA focused process with New Zealand, while charting next steps, and to emphasise the importance of our strong partnership with the US, particularly in the Pacific.
