Report

- Japan hosted the inaugural CPTPP Joint Commission at ministerial level on 20 January 2019 following the entry into force of the agreement on 30 December 2018.
- At the Joint Commission meeting Prime Minister Abe remarked that the CPTPP entering into force was akin to "the birth of a mega economic region of 500 million people". At a time when the global trading system was "gravely shaken" by the rise of protectionism, Abe called the CPTPP a banner for promoting high-standard rules for free and fair trade around the world and reaffirmed that Japan would be its standard bearer. This view was echoed in comments by other Ministers including myself.
- Ministers issued a joint statement highlighting the importance of CPTPP amidst the challenges to the rules-based trading system. The statement noted that "amid growing concerns over recent trends toward protectionism", CPTPP Ministers "shared the view that it is of paramount importance to maintain and further strengthen the principles of an effective, open, inclusive and rules-based trading system".
- Minister's also highlighted the importance of full and effective implementation of the agreement in their remarks and made progress on this front with the adoption of rules of procedure and codes of conduct applying in dispute settlement cases under the agreement. New Zealand's ongoing role as part of the leadership group in CPTPP was confirmed with the Commission decision on future chairing arrangements. New Zealand will host the next set of CPTPP meetings later this year. During the meeting Ministers also emphasised the importance of the remaining four signatories (Peru, Chile, Brunei, Malaysia) ratifying the agreement as soon as possible and agreed on procedures to allow for the accession of new members to the agreement overtime.

It was agreed that New Zealand would follow up with ideas for a proposed work plan for 2019, with a view to Ministers meeting again in the margins of the APEC Ministers Responsible for Trade meeting in Chile in May. I also spoke with other CPTPP participants about ITAG including Peruvian Minister Vasquez, ort Growith who showed interest in learning more about the initiative.

 - . Their reactions to the entry into force of CPTPP were universally positive. I also had lunch with the Japan – New Zealand Parliamentary Friendship League which was a valuable opportunity to have a wide ranging conversation touching on cyber security, health care for the aging population, s6(a) and Brexit.

RETROSPECTIVE APPROVAL FOR OVERSEAS TRAVEL: HON DAVID PARKER

- 1. I seek retrospective Cabinet approval for my travel to Tokyo from 18-22 January 2019. The primary purpose of my travel was to attend the first Joint Commission meeting of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) on 20 January.
- 2. The Prime Minister approved the travel in principle.

Purpose of Travel

- 3. Japan hosted the inaugural CPTPP Joint Commission at ministerial level on 20 January 2019 following the entry into force of the agreement on 30 December 2018. As one of the seven countries (alongside Australia, Canada, Japan, Mexico, Singapore and Vietnam) to have ratified the CPTPP it was important that New Zealand attended at ministerial level to show support for the implementation of this important agreement.
- 4. The Joint Commission meeting also presented an opportunity to hold bilateral meetings with key CPTPP ministerial counterparts and to chair a second meeting of the Inclusive Trade Action Group (ITAG) with Canada and Chile, building on the inaugural meeting of the ITAG on the margins of the APEC Ministerial Meeting last month in Port Moresby. The second ITAG meeting was an opportunity to build momentum for the group, discuss the work programme going forward and discuss additional future membership.
- 5. My trip to Tokyo also presented an opportunity to meet with New Zealand business representatives active in the Japanese market and engage with the New Zealand Parliamentary Friendship League, an organisation that is key to New Zealand's trade and economic interests in Japan. My programme is included as an annex to this paper.

6. I was accompanied by one staff member as part of the Ministerial Delegation. Officials from the Minister of Foreign Affairs and Trade will also attend; their travel costs were covered by the departmental budget.
