MINISTERIAL STRATEGIC ADVISORY GROUP ON TRADE - REAPPOINTMENTS

Proposal

- 1 This paper outlines my intention to reappoint five members to the Trade for All Ministerial Advisory Group for a further term commencing as soon as possible and expiring on 30 June 2023. As a part of the reappointment process I intend to recalibrate the focus of the Group from that originally envisaged and, reflecting this recalibration, to rename it the Ministerial Strategic Advisory Group on Trade.
- 2 This paper has two attachments. The first lists the current and proposed membership and the second is an amended Terms of Reference. An updated Organisation form and Candidate CV forms for all 5 candidates are also attached.

Background

- I established the Trade for All Ministerial Advisory Group (hereafter "the Group") following consultation with Ministerial colleagues and consideration by Cabinet (CAB-21-MIN-0220.01 refers). The Group provides a targeted mechanism through which I can engage with representatives from business, Māori and civil society on New Zealand trade policy. This complements MFAT's intensification and expansion of its engagement with Treaty partners and stakeholders on trade policy issues, under the Trade for All agenda.
- 4 The initial terms of members were staggered; half the Group was appointed for one year terms and the balance for two year terms. A list of current and proposed members is attached as Attachment One.

Comment

- 5 The impact of COVID-19, combined with the emphasis we necessarily placed on concluding the United Kingdom and European Union free trade agreements and the commensurate redirection of resources within the Ministry of Foreign Affairs and Trade, has constrained my ability to agree a work programme with the Group.
- 6 I did however meet with the Group on 31 August to discuss its role moving forward. Reflecting on this discussion, I consider there is value in a Ministerial advisory group whose function is to look into a series of strategic trade policy issues, using financial and information resources provided for this purpose, and then periodically meet with me to deliver and discuss its advice.
- 7 A similar role, albeit not as structured, was envisioned within the original conception of the Group.
- 8 I will be discussing with the Group which strategic trade policy issues it should consider, but it is my intention that the Group first considers how to ensure

New Zealand and New Zealanders take full advantage of the opportunities presented by our free trade agreements, particularly in light of the recent agreements concluded with the United Kingdom and the European Union. Other topics could include 'where to next' in terms of our FTAs, the role of trade in the context of our Trade Recovery Strategy 2.0, trade and climate change and how we make better use of trade missions.

- 9 Shifting the Group's focus to strategic trade policy 'deep dives' requires changes to the Group's:
 - 9.1 Name to better reflect what the Group will do, I propose to rename it the Ministerial Strategic Trade Advisory Group on Trade.
 - 9.2 Terms of Reference to reflect the Group's new focus I propose to update its Terms of Reference and these are attached as Attachment Two.
 - 9.3 Operating Model the Group should self-select a Chair who will drive the Group's work programme on each of the deep dives.
- 10 Central to the success of the Group will be a membership that is reflective of the full range of views on trade policy. To ensure a range of views and in light of the fact that the Group has not yet had the opportunity to get off the ground, I intend to reappoint five of the six¹ members of the Group whose terms expired in early July 2022 for a period to 30 June 2023 (Catherine Beard, Sam Huggard, Hone McGregor, Simon Tucker, and Leeann Watson). These reappointments align the membership terms of proposed members with the current membership and ensures the Group has the critical mass to enable it to settle into its work and develop a work programme, while providing me with an opportunity to consider membership in out-years.

Proposed Candidates' Qualifications for the Position

- 11 I am confident that Catherine Beard, Sam Huggard, Hone McGregor, Simon Tucker, and Leeann Watson possess relevant qualifications, experience and personal attributes that make them suitable for reappointment to the Group:
 - 11.1 Catherine Beard has over 27 years of experience at senior levels across range of industry sectors; including agriculture, insurance, energy intensive sector/climate change policy (large and multinational companies), manufacturing and exporting. She is the Director of Advocacy at BusinessNZ. As an advocate for New Zealand business, including the export and manufacturing sectors, she is uniquely placed to provide insights on, and on behalf of, the export sector. Her relationship to the BusinessNZ network (EMA, Wellington Chamber of Commerce, Canterbury Employers Chamber of Commerce, and Business South) is an entry point into its wider business network.
 - 11.2 Samuel Huggard possesses an extensive background in labour organisation and governance. As former senior leader in the NZCTU he represented the views

of over 320,000 members in 31 trade unions, a significant portion of which are involved in trade and trade-related activities.

- 11.3 Hone McGregor brings wide experience at leadership levels, in the public, private and voluntary sectors, including in export services, finance and research. He is a leader in the Māori agribusiness sector and is Deputy Chair of Te Taumata. Directing a regionally based, export oriented business enables him to provide a regional exporter's perspective.
- 11.4 Simon Tucker is a senior leader with New Zealand's largest exporter and provides an exporters perspective on trade matters. He possesses extensive knowledge of the dairy sector through his previous role as the Executive Director of the Dairy Companies Association of NZ. He was a former High Commissioner to Canada.
- 11.5 Leeann Watson leads the largest business support agency in the South Island with 2700 members. Vastly experienced in business advocacy, she provides a regional and SME perspective and connections into the national chambers of commerce network and the BusinessNZ Network.

Representativeness of reappointment

12 I am satisfied that the five reappointments to the Group continue to provide for a wellbalanced Group in terms of gender, age, ethnicity and geographic representation, and an appropriate mix of skills and experience.

Remuneration

13 The Group is classified as a Group 4, Level 2 Body under the Cabinet Fees Framework. Daily fees have been set in accordance with the Framework. Members will also be reimbursed expenses incurred in relation to attending meetings of the Group.

Reappointment process and consultation

- 14 The five reappointments to the Group were all former members of the Trade for All Advisory Board (TFAAB). The appointment process for the Group therefore leverages the appointment process for the TFAAB (APH-18-MIN-0124 refers) and that used on the first appointment of Group members (CAB-21-MIN-0220.01 refers).
- 15 I consider that reappointing members without consideration of replacement or additional members is appropriate because the work programme of the Group was not able to be developed over the last year.

Conflicts of interest

16 The nature of the Group as a purely advisory body, with membership intentionally selected to be representative of a range of views, means that I do not consider that the usual conflicts of interest inquiries are relevant prior to appointment. While the Group will be required to advise of conflicts of interest during our meetings, I would not expect many such conflicts to arise due to the nature of the Group's advisory function.

Timing and Publicity

17 I do not intend to issue a press statement in relation to these reappointments.

Consultation

18 The Public Service Commission was consulted on this paper.

Recommendation

- 19 It is recommended that the Committee:
 - a) **note** my intention to reappoint those persons identified as proposed reappointments in Attachment One to the renamed Ministerial Strategic Advisory Group on Trade from the date of appointment for a period expiring on 30 June 2023.
 - b) **note** the new Terms of Reference for the Ministerial Strategic Advisory Group on Trade.
 - c) **note** that the Ministerial Strategic Advisory Group on Trade will self-select a Chair in due course.

ATTACHMENT TWO: TERMS OF REFERENCE

Rationale

The Trade for All agenda underpins all of our trade policy, and is essential if trade is to be successful, inclusive and sustainable.

The development of Trade for All included extensive consultation around the country, culminating in recommendations from the Trade for All Advisory Board (TFAAB) on the future of New Zealand's trade policy. Cabinet agreed in March 2020 to implement TFAAB's recommendations.

TFAAB added significant value to the development of the Trade for All agenda. The Ministerial Strategic Advisory Group on Trade (MSAGT) will continue this legacy of the provision of independent policy advice to the Minister for Trade and Export Growth on New Zealand trade policy in a post-COVID era.

Purpose

The role of MSAGT is to provide a targeted mechanism for focused, high-level engagement between the Minister for Trade and Export Growth and representatives from business, Māori and civil society, in order that:

- a) the Minister can engage MSAGT members on matters significant to the trade agenda through a series of deep dives;
- b) members can provide feedback directly to the Minister on trade issues of importance to their sectors; and
- c) cross-sectoral perspectives on the trade agenda contribute to informing Government strategies and priority setting.

The Minister for Trade and Export Growth will meet with MSAGT from time to time (ideally quarterly) in fulfilment of MSAGT's functions.

Membership

MSAGT will consist of a mix of members with different experiences and perspectives on trade and trade policy.

The Minister may invite additional members to ensure that MSAGT is a well-balanced, representative body that reflects those sectors and groups with an interest in trade.

Members will be paid a daily fee set in accordance with the Cabinet Fees Framework together with the reimbursement of expenses incurred in attending meetings.
