### **Proposed Overseas Travel: Hon Nanaia Mahuta**

Portfolio Foreign Affairs

On 27 March 2023, Cabinet:

- authorised the absence of Hon Nanaia Mahuta from New Zealand, subject to leave from Parliament being secured, from 29 to 31 March 2023, to travel to Vanuatu for a bilateral visit;
- 2 agreed that she be accompanied by one member of staff;
- approved the estimated expenditure of up to \$5,808 for the travel expenses of the ministerial party as a charge to Vote: Internal Affairs (Members of the Executive Travel);
- 4 **noted** that she will also be accompanied by officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by their department, and a small media contingent;
- 5 **noted** that the New Zealand Defence Force will facilitate transport to and from Vanuatu;
- agreed that in her absence Hon David Parker act as Minister of Foreign Affairs and Minister for Disarmament and Arms Control;
- 7 **noted** that leave from Parliament has been sought.

#### Proposed Overseas Travel: Hon Nanaia Mahuta

- 1. I seek Cabinet approval to travel to Vanuatu from 29 March 31 March 2023 (inclusive) to undertake a bilateral visit.
- 2. The Prime Minister has approved the travel in-principle, and House leave has been sought from the Party Whip.

#### Reasons for Travel

- If approved, this will be my first visit to Vanuatu and first kanohi ki te kanohi
  engagement with key figures from Vanuatu's recently-elected coalition government. It
  will also be New Zealand's first ministerial engagement with Vanuatu since former
  Associate Minister of Foreign Affairs' visit to Port Vila in November 2022.
- 4. This visit would come in the wake of Aotearoa New Zealand's response to Tropical Cyclones Judy and Kevin, which struck Vanuatu 1-4 March. Aotearoa New Zealand's support so far has been deeply appreciated by Vanuatu, and the Government of Vanuatu welcomes the possibility of a ministerial visit at this time.
- 5. The disaster recovery context provides a unique opportunity to add profile to Aotearoa New Zealand as an effective and responsive partner, one that shows up for our Pacific neighbours when needed. If travel is approved, officials will combine this visit with our response, including transporting further relief supplies. Officials are also exploring bringing a small delegation to support the relief work.
- 6. Aotearoa New Zealand and Vanuatu share a close and warm relationship, shaped by our long-standing people-to-people links, from the first New Zealand missionaries to Vanuatu in the 1960s, through to our education and labour mobility connections today. My first visit to Vanuatu provides a key opportunity to connect in person and discuss how we can strengthen our partnership, work together to advance our shared ambitions, and respond to our shared challenges in the Pacific region. I will advance the bilateral relationship by signing a Statement of Partnership with Vanuatu.
- 7. As evidenced by the recent cyclones, Vanuatu is one of the most disaster-prone nations in the world, and has clearly and repeatedly stated that climate change is its top security concern. We work closely with Vanuatu to advocate for climate action in multilateral fora. This visit would provide an opportunity to celebrate our shared successes, highlight Aotearoa New Zealand's resilience approach and add profile to our efforts to improve social and economic outcomes for ni-Vanuatu. Alongside signing a Statement of Partnership, I will also announce a package of Aotearoa New Zealand development support.

- 9. Vanuatu looks to key partners such as Aotearoa New Zealand and Australia to provide it with friendship and support, including for its security priorities. s6(a)
- 10. It is against this background that I consider it timely for me to strengthen my connections with the Vanuatu Government, and to demonstrate Aotearoa New Zealand's commitment to the bilateral relationship.
- 11. The Key Objectives of my visit will be to:
  - Develop and deepen personal relationships with key political figures in Vanuatu and establish Aotearoa New Zealand as a unique and highly trusted partner;
  - Highlight Aotearoa New Zealand as an engaged and active development partner for Vanuatu and deepen cooperation in support of Vanuatu's priorities, particularly economic recovery and reforms, and human security, including climate change and disaster response; and
  - Reinforce understanding of Aotearoa New Zealand's geopolitical concerns and forge a common perspective on how our two countries can work to strengthen regional security and sovereignty.

#### **Outline of Proposed Visit**

- 12. A portion of my visit will be spent undertaking bilateral engagements with high-level elected officials from the Government of Vanuatu, including the Deputy Prime Minister Sato Kilman and Minister of Foreign Affairs Jotham Napat. During my meeting with Minister Napat, I will sign the Statement of Partnership.
- 13. I will also engage with communities and undertake site visits to highlight the impact of Aotearoa New Zealand's development partnerships and labour mobility programme.

#### Travel

14. If travel is approved, I will depart Aotearoa New Zealand for Vanuatu on 29 March. Officials have confirmed the availability of an NZDF asset to facilitate this travel. The asset will transport further relief supplies and a small delegation to assist with the response to Tropical Cyclones Judy and Kevin. I will also be accompanied by a small contingent of New Zealand media.

15. Should Cabinet approve my travel, my Private Secretary will accompany me, along with officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by the budget of the Ministry of Foreign Affairs and Trade.

  - Approve the expenditure of \$5,808 for the travel expenses of the ministerial party as a charge to Vote Internal Affairs, Members of the Executive – Travel.
