Proposed Overseas Travel: Hon Nanaia Mahuta

- 1. I seek Cabinet approval to travel to Fiji from 13 16 September (inclusive) to participate in the Pacific Islands Forum Foreign Ministers' Meeting (FFMM).
- 2. The Prime Minister has approved the travel in-principle, and House leave has been sought from the Party Whip.

Purpose of Travel

- 3. The Pacific Islands Forum (PIF) remains critical to Aotearoa New Zealand's foreign policy objectives. As the pre-eminent Pacific-led mechanism for regional engagement, the PIF is a core platform for Pacific countries to *talanoa* and build consensus on shared challenges. Aotearoa New Zealand has a strong interest in working with Forum Members to strengthen our collective resilience to current and emerging threats through strong regional unity.
- 4. At the meeting, my objectives will include facilitating agreement of an implementation plan for the 2050 Strategy for the Blue Pacific Continent; reforming the dialogue partner process and shaping discussions on PIF centrality; and reinforcing Pacific leadership on climate ambition and Pacific climate resilience.
- Given the Forum Trade Ministers' Meeting has been deferred, this meeting, following the Forum Economic Ministers Meeting held in August, will be a critical to advance Aotearoa New Zealand's priorities and focus areas ahead of the 52nd Forum Leaders Week, 6-10 November, in Cook Islands.
- 6. If travel is approved, I will depart Aotearoa New Zealand on a commercial flight on 13 September and return by the same means on 16 September.

7. I propose to be accompanied by one Private Secretary from my office and officials from the Ministry of Foreign Affairs and Trade.

Acting Ministers

8. If my travel is approved, I propose that Hon Parker act as Minister of Foreign Affairs, and Minister for Disarmament and Arms Control.
