Proposed Overseas Travel: Hon Nanaia Mahuta

I seek Cabinet approval to travel to Belgium and Sweden over Sunday 2 April – Sunday 9 April 2023 inclusive. Prime Minister Chris Hipkins has approved this travel in-principle.

Executive Summary

- In Brussels over 4-5 April, I will attend the NATO AP4 Summit, and make use of the summit as a platform for engaging with a range of NATO and AP4 partners.
- I will also make a short bilateral visit to Stockholm over 6-7 April to meet with Foreign Minister Billström, and build on our people to people connections, including between Māori and Sámi.
- 4 A visit to Belgium and Sweden would deliver on the following objectives:
 - Reiterate New Zealand remains in lock step with NATO and AP4 partners in supporting Ukraine's self defence in response to Russia's illegal invasion.
 - Signal New Zealand's clear concern about the deteriorating geostrategic environment and the importance we place on working with our like-minded partners to provide collective security, uphold the international rules-based order, and maintain a strategic environment that is consistent with our shared interests and values.
 - Reiterate the importance that New Zealand places on our long-standing relationship with NATO as a valued and like-mirded partner. This is an opportunity for high-level engagement with NATO s6(a)
 - Continue to deepen our values based partnership with Sweden and thank Sweden for its steadfast support for the NZ-EU Free Trade Agreement, s6(a), s9(2)(j)
 - Reinforce the close connections and shared values between Sweden and New Zealand, including by strengthening the relationship between Māori and Sámi.

Outline of Proposed Programme

- Officials are working to secure these programme elements, which will depend on the availability of my counterparts and Sámi contacts.
- 6 During two days in Brussels (4-5 April), I will:
 - attend the NATO AP4 Summit (5 April, half day);

- hold bilateral calls with a range of EU contacts, which may include Josep Borrell, High Representative of the EU for Foreign Affairs and Security Policy, and Jens Stoltenberg, Secretary General of NATO;
- hold bilateral meetings with various NATO members, subject to counterparts' availability (including possibly a meeting with US Secretary of State Antony Blinken);
- participate in a policy dialogue at an event hosted by the European Policy Centre (to be confirmed).
- 7 Over two days in Stockholm (6-7 April), I will:
 - · meet with my Swedish Counterpart, Tobias Billström; and
 - engage with Sámi representatives, which may include the Head of the Sámi Parliament, and a roundtable with the Stockholm Sámi Association to strengthen indigenous connections.

Travel

If my travel is approved, I will arrive in Belgium on Monday 3 April, departing Auckland via Dubai. I will depart Sweden on Friday 7 April, returning to Auckland via Paris and Dubai on Sunday 9 April. The substantive elements of my visit will take place between Tuesday 4 and Friday 7 April.

Ministerial Party

I propose to be accompanied by one staff member paid for by ministerial resources. I will also be accompanied by three officials whose costs will be met by the Ministry of Foreign Affairs and Trade.
