Proposed Overseas Travel: Hon Nanaia Mahuta

Portfolio Foreign Affairs

On 22 May 2023, Cabinet:

- authorised the absence of Hon Nanaia Mahuta from New Zealand, subject to leave from Parliament being secured, from 28 May to 1 June 2023, to travel to the Republic of Korea to attend the inaugural Korea-Pacific Leaders' Summit and undertake bilateral meetings;
- 2 agreed that she be accompanied by one staff member,
- **approved** the expenditure of up to \$23,938 for the travel expenses of the ministerial party as a charge to Vote: Internal Affairs (Members of the Executive Travel);
- 4 **noted** that she will also be accompanied by officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by their department;
- agreed that in her absence Hon David Parker act as Minister of Foreign Affairs and Minister for Disarmament and Arms Control;
- 6 **noted** that leave from Parliament has been sought.

Proposed Overseas Travel: Hon Nanaia Mahuta

1. I seek Cabinet approval to travel to the Republic of Korea from 28 May – 1 June. Prime Minister Chris Hipkins has approved this travel in-principle.

Executive Summary

Purpose of Travel

- 2. As previously agreed, I propose to travel to the Republic of Korea (ROK) to attend the inaugural Korea-Pacific Leaders' Summit and undertake a bilateral programme 29-31 May. New Zealand has a strategic interest in being part of discussions that involve and affect our region, and my attendance at the Summit will also strengthen our relationship with Korea, both bilaterally and in terms of regional cooperation.
- 3. ROK is an important bilateral partner for New Zealand in the wider Indo-Pacific region. We are likeminded and share the same commitment to the rules based international order, human rights and democracy. In 2022 we marked 60 years of diplomatic relations. Further Ministerial engagement would help signal the importance we place on this constructive and valuable bilateral relationship.
- 4. The addition of one day to my visit, after the Pacific Summit, will also enable me to engage with New Zealand business leaders. ROK is New Zealand's 5th largest trading partner and the market is one of our best performing. Two-way trade was NZD6.5 billion in the year to June 2022. In addition, I will have the opportunity to commemorate the 70th anniversary of the armistice of the Korean War, a conflict in which thousands of New Zealanders participated.

Outline of Proposed Programme

- Officials are working to secure these programme elements, which will depend on the availability of my counterparts.
 - In the Republic of Korea, I intend to:
 - Conduct a series of bilateral meetings with Pacific leaders and Korean counterparts including Korean Foreign Minister Park Jin
 - Take part in an event with New Zealand business to promote and support New Zealand exports to Korea
 - Attend a luncheon hosted by the Korean Prime Minister
 - Attend the Korea-Pacific Leaders' Summit
 - Attend a State Dinner hosted by the Korean President and First Lady
 - Travel to Busan with Pacific Leaders and attend a luncheon hosted by the Mayor of Busan
 - Commemorate the 70th anniversary of the Armistice of the Korean War.
