Proposed Overseas Travel: Hon Nanaia Mahuta – East Asia Summit, Jakarta, 6-8 September 2023

- I seek Cabinet approval to travel to Jakarta, Indonesia from 6 to 8 September to represent Aotearoa New Zealand at the East Asia Summit (EAS).
- 2 Prime Minister Chris Hipkins has approved this travel in-principle.

Executive Summary

- The annual Leader-level East Asia Summit (EAS), convened by the ASEAN Chair (this year Indonesia), will be hosted in Jakarta on 7 September. Attended by the 10 members of ASEAN as well as Australia, China, India, Japan, Aotearoa New Zealand, South Korea, Russia and the United States, the EAS is considered to be the region's premier leaders' forum for addressing strategic challenges, particularly in our wider home region of the Indo-Pacific.
- Aotearoa New Zealand is an engaged and constructive partner to ASEAN, with an interest in its strength and success. Aotearoa New Zealand has cultivated a reputation based on respect, reliability and our support for ASEAN's centrality in the region. Attendance at these meetings at a senior political level is an important aspect of maintaining our profile as a committed and reliable partner with ASEAN. We have the opportunity to register our views and also take the pulse on issues impacting the region such as Russia's war against Ukraine, Myanmar, DPRK and South China Sea.
- If time and availability permits, I would also meet with my Ministerial counterparts from ASEAN and from other EAS participating and observer countries to discuss issues of mutual importance.
- 6 My participation in the EAS would deliver on the following objectives:
 - Maintain Aotearoa New Zealand's profile and influence in a competitive geopolitical environment;
 - Re-emphasise Aotearoa New Zealand's positions on the core issues affecting the rules-based order and strategic environment in our region;
 - Demonstrate the importance of Southeast Asia to Aotearoa New Zealand through support for Indonesia's flagship event, the ASEAN Indo-Pacific Forum.
