Report to Cabinet: Minister of Foreign Affairs' Visit to Fiji, 15-17 March 2023

- 1 I recommend that Cabinet note this report on my travel to Fiji on 15-17 March 2023.
- 2 My visit to Fiji in mid-March established strong foundations for longer-term relationships with key Fijian stakeholders. My meetings with Prime Minister Sitiveni Rabuka, senior Fijian Cabinet Ministers, and MPs, reinforced the strong, wide-ranging, and highly valued areas of cooperation between New Zealand and Fiji, which are becoming increasingly mature as Fiji continues to build its leadership role within the region. The visit set the scene well for ongoing relationship building.
- 3 My discussions with stakeholders traversed a wide range of topical issues, including women's leadership, indigenous governance, trade and investment opportunities, democratic strengthening, social well-being, climate change, disaster management, cultural and whakapapa connections, Pacific regionalism, and beyond. Throughout my visit, Fijian stakeholders commented on the value of the varied areas of cooperation between our two countries.
- 4 The visit also illustrated the Pacific Resilience principles in practice through the nexus of our foreign policy and International Development Cooperation, and included a particular focus on the recognition of deep and enduring whakapapa connections brought to light during a culturally significant visit to Bau island.
- 5 The trip met Aotearoa New Zealand's objectives and reaffirmed our commitment to Fiji. The objectives for my visit were to:
 - 5.1 Build a relationship with the new Fiji Government leadership who were elected in late December 2022;
 - 5.2 Reinforce Aotearoa New Zealand's position as a natural partner for Fiji in the region and demonstrate solidarity on important issues such as climate change and regional security;
 - Discuss geopolitical developments in the Indo-Pacific region and reflect on Fiji's recent hosting of the PIF Special Leaders' Retreat;
 - 5.4 Highlight the important role the New Zealand International Development Cooperation programme plays supporting Fiji partners to deliver long-term social and economic resilience for the Fijian people; and
 - 5.5 Express thanks for the deployment of Fiji military and emergency personnel to support the Cyclone Gabrielle response.

Dinner with Fijian Cabinet Ministers

13 A dinner at the New Zealand Official Residence with six senior Fijian Cabinet Ministers enabled a rich discussion on topical issues for Fiji and its relationship with Aotearoa New Zealand. s6(a)

Prime Minister Rabuka and I held a warm and engaging meeting that covered many facets of the bilateral relationship, as well as key regional issues. I acknowledged the success of the PIF leaders' meeting and noted that it sent a strong signal about regional solidarity, and the need to focus on common objectives. s6(a)

Meeting with FijiFirst opposition representatives

14 My meeting with the FijiFirst opposition took place in the wake of the suspension and then resignation from parliament of previous Prime Minister Frank Bainimarama. Senior FijiFirst MPs Faiyaz Koya and Ioane Naivalurua attended the meeting, which Affairs was warm and constructive. s6(b)(i)

Bau Island visit

15 My visit to Bau island was deeply significant. Bau lies at the heart of the chiefly system in Fiji as the seat of the recently installed Paramount Chief of the Kubuna Confederacy (widely considered to be the highest-ranked Chief in Fiji), Turaga na Vunivalu na Tui Kaba, Ratu Epenisa Cakobau. Outsiders cannot ordinarily visit the island unless invited and this was likely to have been the first ever visit by a government minister from outside Fiji. Ratu Epenisa and Thad a friendly and relaxed exchange, where we discussed long-standing cultural and familial connections between New Zealand and Fiji, and the re-establishment of the Great Council of Chiefs, which would meet on Bau island in May this year.

Koroipita Development Project

- I visited the New Zealand-funded Model Towns Charitable Trust site at Koroipita to 16 highlight the benefits that long-term and enduring partnerships can have on communities. Residents, Board Members and staff of Koroipita discussed the positive impact of Koroipita on their lives, particularly the livelihoods training, social welfare services, and financial literacy courses provided by the initiative.
- 17 Detailed reporting has been produced by the New Zealand High Commission in Suva and circulated through the Ministry of Foreign Affairs & Trade's formal message system.
