- There are 261 New Zealanders still registered as being in Israel, but the number that are seeking consular assistance is much lower. MFAT is focusing on a smaller group of 57 who they have been unable to contact to confirm their travel intentions or who have indicated they want to leave.

- As at 5pm Sunday 15 October, we have assisted 37 New Zealanders to leave Tel Aviv on Etihad Airways flights to the UAE. A third and final flight is scheduled for early Monday morning (NZT) and is expected to carry a number of New Zealanders and Pacific Island nationals.
- As a contingency to assist with the consular response, I and the Minister of Defence (with the PM's concurrence) approved on Saturday the deployment of a RNZAF Boeing 757 aircraft to the region. 

While multiple airlines have suspended flights to Tel Aviv, Ben Gurion Airport remains open and commercial flights continue to operate. New Zealanders should not change their existing flight arrangements if these are unaffected.

We have secured a limited number of seats on a regularly scheduled Etihad Airways flight from Tel Aviv to Abu Dhabi on Saturday 14<sup>th</sup> October. There will be a charge associated with this flight and you will need to sign an undertaking to repay before boarding the flight.

Seats on this flight will be available on a first in, first served basis to New Zealand passport holders, New Zealand permanent residents and Pacific Island passport holders.

You must meet UAE entry requirements to be eligible to take this flight.

Please note that final decisions regarding the operation of this flight rest with the airline.

You will be responsible for all travel costs incurred in Abu Dhabi as well as onward travel arrangements and associated costs. We encourage you to reach out to your travel insurer, if you haven't already done so.

### Advice on Assisted Departure options for New Zealanders in Israel

The Ministry has been actively exploring options to assist New Zealanders to depart Israel following Hamas' attack on 7 October and subsequent fighting.

We have been working on two options. These are outlined below. s6(a)

### Option 1: Charter a commercial plane

# Given this high degree of uncertainty in departure options for New Zealanders, we strongly recommend accepting Etihad's offer.

This is a significant recommendation and one that the Ministry does not take lightly. Our preferred approach in these situations is always to rely on New Zealanders making their own arrangements while that remains an option. But the mix of considerable uncertainty in this case, the need to provide urgent assistance to New Zealanders that could be exposed to heightened conflict in the region, s6(a)

underline why we are strongly recommending that we move ahead now with Etihad. Confirming this option will also provide New Zealanders in Israel greater certainty to arrange their onward travel.

While it is difficult to assess the numbers of New Zealanders that will choose to avail themselves of this option, the ninety available seats would provide an option

for around 55% of non-resident New Zealanders currently registered as being in Israel.

- There are a number of challenges that we will need to overcome to make this option work:
  - o One is timeframes. Etihad has advised that we must advise them by Thursday morning NZT if we wish to take up this option. Otherwise they will release the seats to the market, which they expect will be sold very quickly. For this reason, unless you or the Prime Minister directs us otherwise by 11:30am, we will confirm to Etihad that the Ministry will take up the option to purchase these seats (funded from our baseline).
  - A second question is whether or not New Zealanders should be charged, in some way, for travelling on this flight. This is a complex issue and a decision will be needed today. We will provide you with further advice this afternoon. Either way, any costs not passed on to New Zealanders availing themselves of this flight will be met from the Ministry's baseline.
  - o A third issue will be the logistical challenges in managing flight arrangements and liaising with New Zealanders in Israel. A dedicated team is being established this morning to focus on this, which will include consideration of what on-the-ground presence at Ben Gurion Airport may be required by New Zealand consular officials.
  - o A fourth issue we need to be mindful of is the possibility that Etihad suspends services to Tel Aviv before Saturday's scheduled flight.





NEW ZEALAND DEFENCE FORCE DEPLOYMENT TO SUPPORT THE ASSISTED DEPARTURE OF NEW ZEALANDERS FROM ISRAEL AND MIDDLE EAST

### **Purpose**

To seek approval to deploy a Boeing 757-2K2 aircraft and up to 39 New Zealand Defence Force Personnel to the Middle East region for up to 30 days, to assist the Ministry of Foreign Affairs and Trade with consular efforts to facilitate the departure of New Zealanders and approved individuals from Israel or other locations in the Middle East region.

# Background

- 1. The Ministry of Foreign Affairs and Trade (MFAT) has stood up an Emergency Crisis Centre to manage the consular response to the Israel/Gaza conflict.
- 2. As part of this work, MFAT is working with Etihad Airways to facilitate the departure of New Zealanders who want to leave Israel. One flight departed from Tel Aviv earlier today (Saturday) with ten New Zealanders on-board. A further 46 travellers are booked on Etihad's Saturday service and will arrive in Abu Dhabi at 4am on Sunday (NZT). Demand for a third flight on Sunday has so far been low but could surge if commercial departure options from Israel continue to decline or stop altogether. MFAT's advice to New Zealanders who want to leave Israel, is to do so now.
- 3. These departure flights terminate at Abu Dhabi. MFAT has been clear to travellers that they are responsible for making onward travel arrangements. s6(a)
- 4. MFAT has requested support from the New Zealand Defence Force (NZDF), through the deployment of a Boeing 757-2K2 aircraft, to provide strategic airlift to support the consular response. NZDF is able to provide support to other government

agencies, and in support of mandated government activities such as consular efforts, subject to the approval of relevant Ministers [CAB-21-MIN-0439].

The situation in Israel remains fast evolving. It is hard to predict with certainty what task the Boeing 757-2K2 could most usefully undertake, or even if it will be required. However as it will take 2-3 days for the aircraft to reach the region, officials think it is prudent to seek Ministerial permission now with the best information to hand, and provide updates if and as the situation evolves.

### Rationale for deployment

- NZDF support is requested for the following reasons: 6.
  - a) To provide contingency options against the possibility that a significant number of New Zealanders become stranded in Abu Dhabi due to the unavailability of onward flights. Currently, the risk of this is assessed as medium. While capacity exists on Emirates, Qatar Airways and Singapore Airlines' routes, it is limited. Availability could also decline quickly as departures from Israel grow.
  - b) To provide a potential contingency to evacuate New Zealanders from Tel Aviv FFICIAL INTOIN whom are not able to depart Tel Aviv, s6(a)

c) s6(a)

### Proposed deployment

- It is proposed that Ministers approve the deployment of: a Boeing 757-2K2 and up to 39 NZDF personnel to the Middle East/Europe region for up to 30 days from the planned date of departure (currently 16 October) of the Boeing 757-2K2.
- The NZDF Boeing 757-2K2 is currently scheduled to depart New Zealand not before 06:00 on Monday 16 October from Royal New Zealand Air Force Base Whenuapai, Auckland and arrive in the Middle East region on 18 October.

The aircraft would be available to undertake airlift activities in support of the consular response between locations in the Middle East region, including Abu Dhabi

(UAE) and, if needed s6(a) (Israel).

. Tel Aviv

- 12. The NZDF contingent will comprise the following types of specialists:
  - Aircrew,
  - Operations personnel,
  - Maintenance personnel, and
  - Logisitics personnel.
- 13. It is proposed that the Minister of Defence and the Minister of Foreign Affairs be advised of any increase beyond the initial 39 personnel. Approval from the Minister of Defence and the Minister of Foreign Affairs would also be sought if the deployment is likely to exceed 30 days in duration, s6(a)
- 14. To support the operation and provide consular support to New Zealanders on the Jer Hue Official Inflorma ground, a small MFAT team of up to four persons would be included as part of the deployment.

#### Risks and considerations

15. s6(a)

While at present the security situation in Israel remains acceptable, it is possible that the conflict in Israel/Gaza may escalate. In this context, it is possible that that security situation in Tel Aviv would be prejudicial to the health and safety of deployed personnel. To mitigate this risk, NZDF will continue to assess the situation and will not deploy to any non-permissive location or if the risks to health and safety exceeds the approved risk level.

### Threat level

18. However, the situation on the ground is still developing and remains uncertain. The overall security environment could deteriorate rapidly with little warning.

#### Financial implications

19. The estimated cost of the proposed deployment of the Boeing 757-2K2 is \$0.850M - \$1.02M. The cost can be funded from NZDF baselines.

### **Legal Considerations**

### Legal Basis

20. The deployment will at all times only enter the airspace and territory of other countries with the consent of those countries, and will at all times comply with international law. In particular, any flights into Israeli air space will only occur with prior permission of the Israeli government.

## Rules of Engagement

- 21. The facilitiated departure of New Zealand nationals is a defensive operation in nature and the application of force is limited to self-defence of the force, New Zealand nationals, and any other group of people for which there is a duty to protect. There is also a requirement to be able to conduct those activities which are necessary and incidental to the performance of the departure.
- 22. The NZDF contingent will be not be armed, and will operate under the New Zealand Standard Self Defence Rules of Engagement (NZSSDROE). This is an expression of section 48 of the Crimes Act 1961 in the form of orders. If there is a requirement for additional authorisation on the use of force, a separate request will be made through the Minister of Defence to the Prime Minister for consideration.

### Law of Armed Conflict

23. As this is an assisted departure of New Zealanders and other eligible persons only, the deployment will in no way be involved in the long-standing broader Israel-Palestine conflict, including current hostilities between Israel and Hamas. Any actions taken by NZDF would only be in self defence in order to protect nationals and would not amount to participation in the armed conflict.

#### Civilian Casualties

24. As this is an unarmed assisted departure of New Zealanders, no civilian casualties are expected. The situation on the ground in Israel is dynamic. Where lawful military action results in civilian harm, the reporting requirements in Defence Force Order 35 are to be followed as soon as reasonably practicable. Due to the nature of the activity this may be on return to New Zealand.

### **Human Rights Risk Assessment**

- 25. A human rights risk assessment (HRRA) would not typically be required for a facilitated departure of this nature, and officials have not conducted one. Should the situation change, officials would conduct a HRRA to ensure any risk of Detainee Handling.
- 26. Although detainee handling is considered to be a remote possibility as a consequence of this deployment, officials will consider the risks associated. If risk and likelihood are assessed to be significant, officials would advise Ministers on approach.

### Consultation

27. This paper has been jointly prepared by the Ministry of Defence and the New Zealand Defence Force, and the Ministry of Foreign Affairs and Trade.

### Recommendations

28. It is recommended that you:

a) **Note** that the Ministry of Foreign Affairs and Trade has requested the support of the New Zealand Defence Force, as part of its efforts to assist the departure of New Zealanders and other approved individuals from Israel, due to the promixity of the Israel/Gaza conflict.



This is a message from the New Zealand Ministry of Foreign Affairs and Trade and follows previous advice regarding the outbreak of armed conflict on 7 October. This message has been sent to you as your registration details indicate you are currently in Israel. Please update your <u>registration</u> <u>details</u> if this is not the case.

Please ensure that your SafeTravel registration includes important information such as **up-to-date** contact phone numbers, location and email addresses.

The **final** New Zealand Government assisted departure flight from Tel Aviv Ben Gurion Airport will depart today, Sunday 15 October, to Abu Dhabi. If you wish to leave Israel, **this is your final opportunity to depart on a New Zealand Government supported flight**. We have no further assisted departure flights planned.

There are still a limited number of seats available for today's flight but you need to book urgently to secure a seat. We cannot hold seats. Spaces are allocated on a first-come, first-serve basis.

If you are booked on this flight you should arrive at the airport as early as possible and - at a minimum - at least 3 hours before departure.

The following individuals are eligible for these flights:

New Zealand citizens; New Zealand Permanent Residents; Immediate family members traveling with New Zealand citizens; or Pacific Islands nationals.

You must also be eligible to enter the UAE (have a valid UAE entry visa or have the right to transit through the UAE to catch a confirmed onward flight).

You should check with your travel agent or with the <a href="Embassy or High Commissions">Embassy or High Commissions</a> of the countries you intend to visit or transit to find out their visa / entry requirements and if you need to apply for a visa. If you require a visa for the UAE, you **must** have this issued for you to be eligible for these flights. If you do not have a visa and need one, you will not be issued with a ticket and will not be able to travel on these flights.

Seats on these flights are being allocated on a first-come, first-served basis. The process for securing a seat on these flights is as follows:

The email must have the following in the email subject line: "New Zealand Government Assistance flight to Abu Dhabi".

Interested passengers must then include the following in the email:

1) If they are a New Zealand citizen, a photo of their passport bio-data page;

2) If they are not a New Zealand citizen, a photo of their passport bio-data page, and a photo of their New Zealand Permanent Residency visa and their visa for the UAE; OR

A copy of their onward ticket to their final destination to ensure they have the right to transit the UAE.

Etihad Airways will respond to you directly advising whether you have been successful in securing a booking, or whether the allocation for your selected flight has been exhausted.

On arrival at Tel Aviv Airport, you will be required to complete an 'undertaking to repay' document before checking in for your flight. This commits you to repayment of the above flight cost (NZ\$330) within 90 days.

#### Other important notes:

Final decisions regarding the operation of these flights rest with the airline

Those undertaking onwards travel need to allow time to clear immigration (where needed) and to allow time to collect luggage.

You will be responsible for your costs in Abu Dhabi and making onward travel arrangements at your own expense. Please note that there may be limited availability of onwards flights to return to New Zealand and you may need to consider arranging forward travel through nearby travel hubs such as Dubai, Doha, Singapore or Istanbul. Your travel agent will be best placed to provide advice on options. We also encourage you to reach out to your travel insurer, if you haven't already done so.
