We refer to your email of 1 August 2024 in which you request the following under the Official Information Act 1982 (OIA):

'please provide all written advice, briefings, notes, reports, and aides-memoire produced on the AUKUS Trilateral Security Pact between 22 June 2024 and 1 August 2024.'

In scope of your request is one document titled "NSB Briefing for CE". This document primarily provides advice to the Ministry of Foreign Affairs and Trade's (the Ministry) Chief Executive on the Ministry's internal perspectives on interagency coordination processes, which relate to the Government's workstream exploring how New Zealand could potentially participate in AUKUS Pillar Two.

In accordance with section 16(1)(e) of the Official Information Act, please see the following excerpts of the information you requested. We have chosen to provide a summary as providing the information in another form would prejudice the interests protected by section 6 and 9 of the OIA. I note that some information is not provided in the summary because it is withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government; and
- 9(2)(g)(i): to protect the free and frank expression of opinions by departments.

## **Excerpt one**

The Ministry continues to work closely with MoD and NZDF on efforts to explore potential New Zealand participation in AUKUS Pillar II. Recent (joint MFAT-MoD) advice to Ministers has outlined:

- Specific areas of likely interest to New Zealand to be further explored;
- Key information gaps on the mechanics and costs of participation;
- Foreign and national security policy considerations;
- And next steps in terms of continued engagement with the AUKUS partners.

## **Excerpt two**

The inherently interwoven foreign, defence and national security policy dimensions of AUKUS means that, [withheld under section 9(2)(g)(i)]. Previous substantive papers to Ministers (including the most recent one attached) have been joint papers to MFA and MinDef.
