Thank you for your email of 22 August 2024 in which you request the following under the Official Information Act 1982 (OIA):

- 1. On what basis are general consent export permits granted for controlled goods instead of the other types of export permit (single permit, single temporary permit, multiple permit)?
- 2. When the Export Controls Team assesses an export permit application, who does it usually consult with in order to assess criteria 2 (consistency with Aotearoa New Zealand's obligations, commitments and policies regarding fundamental principles of international law, as well as international human rights law and international humanitarian law) and criteria 3 (consistency with Aotearoa New Zealand's other international obligations, commitments and policies)?
- 3. Do end user certificates need to be provided to MFAT where an export permit holder is exporting controlled goods to end users pursuant to a general consent?

A response to each part of your request is set out below.
