Thank you for your letter of 11 November 2024 in which you request the following under the Official Information Act 1982 (OIA):

- 1. Any reports, emails or documents since 1 October 2022 with regards to the Cook Islands proposed passport or identity document.*
- 2. •This also includes the potential implications/concerns for the Cook Islands/NZ constitutional relationship.*
- 3. •This includes any queries, demands or proposals from the Cook Islands Ministry of Foreign Affairs and Immigration and the Cook Islands Prime Minister and his office on this issue.*
- 4. This also includes advice or information to and from MFAT to the NZ Foreign Minister's and NZ Prime Minister's offices.*

We have numbered your request for administrative convenience.

On 9 December 2024, the timeframes for responding to your request were extended by an additional 20 working days because responding to your request necessitated the review of a large quantity of information, and due to the consultations necessary to make a decision on your request (section 15A(1)(a) and (b) of the OIA refers). The Ministry of Foreign Affairs and Trade (the Ministry) uses Formal Messages as a reporting mechanism. There are eleven Formal Messages in scope of your request. They are listed in the document schedule included as **Annex A**.

Two Formal Messages dated 16 August 2024 and 17 October 2024 have been withheld in full, including their titles, under sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government; and
- 7(b)(i) and 7(b)(ii): to avoid prejudicing relations between the Governments of New Zealand and the self-governing State of the Cook Islands:

Three Formal Messages have been provided to you as excerpts (section 16(e) of the OIA refers). They are in **Annex B** as excerpts one, two and three.

The remaining six Formal Messages in scope of this part of your request are attached. Some information is withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand or the international relations of the New Zealand Government; and
- 7(b)(i) and 7(b)(ii): to avoid prejudicing relations between any of the Governments of New Zealand and the self-governing State of the Cook Islands.

In relation to your request for emails regarding *the Cook Islands proposed passport or identity document*. An initial search for emails potentially in scope of this part of your request captured over 180 emails in two email inboxes. Collating and reviewing each of these emails to assess if they are potentially in scope of your request would require a significant amount of resource. Accordingly, this part of your request is refused under section 18(f) of the OIA, as the information you requested cannot be made available without substantial collation and research.

There are nine documents in scope of your request. They are listed in the document schedule is included as **Annex C**.

Four documents have been provided to you as excerpts (section 16(e) of the OIA refers). These are in **Annex D**. Some information has been withheld under sections 7(b)(i) and 7(b)(ii) of the OIA, to avoid prejudicing relations between the Governments of New Zealand and the self-governing State of the Cook Islands.

The document titled 'Informal Note — Cook Islands Joint Declaration: testing comfort with approach and next steps' has been withheld in full under sections 7(b)(i) and 7(b)(ii) of the OIA, to avoid prejudicing relations between the Governments of New Zealand and the self-governing State of the Cook Islands.

The remaining five documents are attached. Some information is withheld under the following sections of the OIA:

- 7(b)(i) and 7(b)(ii): to avoid prejudicing relations between any of the Governments of New Zealand and the self-governing State of the Cook Islands; and
- 9(2)(a): to protect individuals' privacy.

Some information has been withheld under sections 7(b)(i) and 7(b)(ii) of the OIA, to avoid prejudicing relations between the Governments of New Zealand and the self-governing State of the Cook Islands.

In addition, we have supplied you with a further two documents which did not exist at the time your OIA was submitted. These documents provide more current information and aid understanding of the topic. These documents are:

Prime Minister Brown is the current Chair of the Pacific Islands Forum (PIF), which will be passed on to Tonga at the upcoming Leaders Meeting in Tonga, 26 – 30 August 2024. He holds the Ministerial responsibilities for Finance and Economic Management, Attorney General, Public Service Commission, Police, Seabed Minerals Authority, Tourism, Energy and Renewable Energy Outer Island Special Projects and Telecommunications.

1 Prime Minister Luxon met with Cook Islands Prime Minister Brown in Auckland on 12 August, while the latter was transiting through Auckland from the Forum Foreign Ministers Meeting (FFMM). This was their first meeting as Prime Ministers, though, as PM Luxon reminded, they had met previously when he had been CE of Air New Zealand and PM Brown had been Finance Minister. PM Brown was accompanied by Secretary of MFAI, Tapaeru Herrmann, and the new Deputy High Commissioner Amelia Fukofuka-Murae. The meeting was pitched primarily as an introductory meeting, to give the Prime Ministers the opportunity to get to renew their acquaintance in advance of the Pacific Islands Forum Leaders Meeting (PIFLM), and noting that they will have the opportunity to meet in a formal context under the new Leaders level architecture of the bilateral relationship (PACPF's FM 28 May refers).

While we understand the purpose of this meeting is to discuss planning for the Joint Ministerial Working Group, this is the first time you will have had the opportunity to engage with Hermann on the Minister's letter.

1 After delays due to the High Commissioner's availability, on Wednesday 8 October, PACPF (Coombs and Hyndman) met with the Cook Islands High Commissioner (Samuela), Deputy High Commissioner (Fukofuka-Murare), and First Secretary (Arthur). 2 PACPF DM recalled that PM Brown had first raised his proposal for a Cook Islands passport with Minister Peters at PALM10 in July, and then with Prime Minister Luxon in Auckland on 12 August (RRO FM 7 Aug and PACPF FM 13 Aug refer). On both these occasions, and subsequently by officials, we had indicated the proposal raised significant questions for our constitutional relationship and had requested more information in writing so that we could respond accordingly. s7(b)(i), s7(b)(ii)

PACPF DM explained that the Minister thought it important to provide New Zealand's views in writing so that our position, which was based on our constitutional relationship and shared citizenship, was clearly understood by the Cook Islands. PACPF DM elaborated that if the Cook Islands Government wished to establish a national identity card for domestic purposes, then that is a matter for the Cook Islands to consider. A passport however would raise fundamental questions for our constitutional relationship. These are questions that ultimately the Cook Islands people would need to address.

Dear Prime Minister

It has been a pleasure to see you in recent months, including in Tokyo and Nuku'alofa.

We are looking forward to marking the 60th Anniversary of the Cook Islands self-government in free association with New Zealand next year. Our relationship has developed and succeeded over the last 60 years because of the willingness of our Governments and leaders to engage in open and frank dialogue. This recognises the strength that comes from our shared culture, history and people, and desire to work in true partnership. The reflections in this letter are shared in that spirit.

It has been useful for the New Zealand Government to hear some of your thoughts on Cook Islands' initiatives to mark the 60th anniversary, including the proposal to create a Cook Islands passport. Given the constitutional significance of some of these suggestions, we thought it important to offer some feedback in writing.

As we approach the 60th Anniversary, it is a timely moment to reflect on our constitutional relationship. The Free Association model established between New Zealand and the Cook Islands and endorsed by the United Nations General Assembly on 16 December 1965 (GA Resolution 2064(XX)), is an inherently flexible concept. It has allowed our relationship to naturally progress and evolve over time. The Cook Islands has exercised self-governance under its Constitution and grown its interaction with the international community at its own pace while retaining a foundational constitutional connection with New Zealand.

As members of the Realm of New Zealand, we share a sovereign citizenship and owe constitutional responsibilities to one another. s7(b)(i), s7(b)(ii)

Our relationship has benefitted from the flexibility and unique character of Free Association and New Zealand remains committed to it. While flexible, Free Association and membership of the Realm of New Zealand has limits. Under international law, it is constitutionally distinct from full sovereignty and independence. If and when the Cook Islands wished to contemplate fundamental change towards full sovereignty and independence, New Zealand would stand ready to engage on that. We recognise that this is rightly a question for the Cook Islands Government and its people. As has been the practice with major constitutional changes in New Zealand, we would expect any fundamental evolution to the Cook Islands' relationship

with New Zealand would need to be subject to a referendum process involving the people of the Cook Islands.

In this context, we noted your intention to create a national identity card or Cook Islands passport next year. The creation of a national identity card is a question for the Cook Islands Government. However, the establishment of a passport is a separate question as passports flow from citizenship. The New Zealand Government is responsible for the passports of New Zealand citizens and these passports are governed by New Zealand law. A Cook Islands passport would raise fundamental questions for our constitutional relationship and shared citizenship.

Dear Prime Minister

Thank you for your letter dated 6 November 2024. We greatly appreciated the opportunity to meet you on 19 November 2024 to further discuss the proposals in your letter, namely the creation of a Cook Islands citizenship and passport.

As discussed during our recent meeting, like the Cook Islands, New Zealand deeply values our unique bilateral relationship and wants it to continue to flourish.

However, as was made clear during your meetings in the Beehive on 19 November, the New Zealand Government cannot support your proposal for a Cook Islands citizenship and passport. The Realm of New Zealand has one sovereign and one citizenship. This is a foundational concept that underpins the Realm and our free association model.

Any proposal to change this foundational concept would need to be agreed in partnership with New Zealand and would need to be put to the people of the Cook Islands through a referendum. The New Zealand Government's approach to this matter would also be carefully scrutinised in our own political system and be subject to challenge from a range of stakeholders. It would therefore be a requirement for such a matter of constitutional significance to also be taken to the New Zealand Cabinet for agreement.

The New Zealand-Cook Islands relationship has thrived over many years, through the careful and mature management of challenging issues via respectful consultation, and we are confident that it will continue to do so.
