# Proposed Overseas Travel: Rt Hon Winston Peters - June 2024

Portfolio

**Foreign Affairs** 

On 20 May 2024, Cabinet:

- 1 authorised the absence of the Rt Hon Winston Peters from New Zealand, from 4 to 13 June 2024, to travel to Viet Nam, Malaysia, the Philippines and Timor-Leste to undertake bilateral engagements;
- 2 agreed that he be accompanied by one member of staff.
- 3 approved the estimated expenditure of up to \$65.751 for the travel expenses of the ministerial party as a charge to Vote Internal Affairs (Members of the Executive Travel);
- 4 noted that he will also be accompanied by officials from the Ministry of Foreign Affairs and Trade, whose costs will be met by the Ministry;
- 5 agreed that in his absence:
  - 5.1 Hon Judith Collins KC act as Minister of Foreign Affairs;
  - 5.2 Hon Chris Bishop act as Minister for Racing;
- 6 noted that the House is not sitting during his absence.

Proposed Overseas Travel: Viet Nam, Malaysia, Philippines, and Timor-Leste, 4 to 13 June 2024.

- I seek Cabinet's approval to undertake official travel to Viet Nam, Malaysia, Philippines, and Timor-Leste from Tuesday 4 June to Thursday 13 June 2024.
- 2 The Prime Minister's office has approved this travel in-principle

### Purpose of Travel

- My visit to South East Asia supports the government's plan to increase New Zealand's focus on our important relationships in South East Asia, a region critical to New Zealand's prosperity and security. If approved, we intend to travel to Viet Nam, Malaysia, Philippines, and Timor-Leste for bilateral engagements with my Foreign Minister counterparts and other relevant political leaders. We will register New Zealand's ambition to rejuvenate engagement with key partners in the Indo-Pacific, and note our shared values, interests, and strategic direction in the region.
- A visit to the region, so quickly after the Prime Minister's mission, will underline to our partners that South East Asia matters to New Zealand, and will further signal the high tempo of engagement New Zealand intends to carry forward in the coming years. The destinations selected for this travel both maintain momentum gained from the recent visits (Viet Nam and Philippines) and renew face-to-face engagement where high-level visits are long overdue (Malaysia and Timor-Leste).
- 5 We will use this visit to pursue a number of objectives in each country.

#### Viet Nam

Wiet Nam and New Zealand will celebrate 50 years of diplomatic relations in 2025. In the same year New Zealand will commemorate 50 years of dialogue relations with ASEAN. Viet Nam will take over as New Zealand's country coordinator with ASEAN in July 2024, making it a critical partner during our 50th anniversary year with ASEAN s6(a)

- 7 While in Viet Nam we will seek to:
  - capitalise on the momentum arising from the Vietnamese Prime Minister's visit to New Zealand in March 2024;
  - advance our ambition to further elevate our bilateral Strategic Partnership; and
  - seek a political commitment to enhance air services arrangements between New Zealand and Viet Nam s6(e)(vi), s9(2)(b)(ii)

### Malaysia

- 8 Malaysia will chair ASEAN next year, when we look to hold a commemorative Summit with ASEAN Leaders, likely in the margins of the East Asia Summit in late-2025.
- 9 While in Malaysia, we will seek to:
  - further deepen the New Zealand-Malaysia bilateral relationship, building on the foundations laid through the bilateral Strategic Partnership signed in 2023; and
  - participate in the inaugural annual Foreign Ministers talks, agreed under the Strategic Partnership in 2023.

## **Philippines**

- The Philippines under the current Marcos administration is a country both youthful and dynamic offering opportunities for New Zealand business and labour market alike s6(a)
- 11 While in Philippines, we will seek to:
  - build on momentum gained from the Prime Minister's mission to the Philippines in April;
  - reiterate New Zealand's commitment to strengthening our bilateral relationship, including launching discussions on the Roadmap to elevating our bilateral relationship to a Comprehensive Partnership;
  - seek agreement on the main pillars of the roadmap to achieve Comprehensive Partnership Status with the Philippines and a timeframe for launching the Roadmap;

- progress timeframes for concluding a Status of Forces Agreement with the Philippines;
- secure support from Philippines Department of Foreign Affairs for regaining market access for onions;
- confirm a contribution to the ASEAN Centre for Biodiversity, hosted in the Philippines;
- witness the signing of a memorandum of arrangement with the Philippines Anti-Red Tape Authority and New Zealand consultancy oreidn Aff Creative HQ; and

#### Timor-Leste

- No Foreign Minister from New Zealand has visited Timor-Leste for a decade, 12 despite the close relationship established during the forging of the country's independence. Timor-Leste now stands at an inflection point, poised to become a member of ASEAN, yet with significant development challenges and diminishing oil and gas revenues.
- 13 While in Timor-Leste, we will seek to
  - re-connect with the political leadership of Timor-Leste and demonstrate New Zealand's continued support for Timor-Leste's development and regional integration;
  - s9(2)(f)(iv)
  - extend New Zealand support for English Language Training for Timor-Leste officials in support of that country's membership of ASEAN.

### **Outline of Proposed Visit**

- 14 During my visit to Viet Nam, we intend to travel to Ha Noi and seek the following calls and undertake the following engagements:
  - Meet Minister of Foreign Affairs Bui Thanh Son;
  - Courtesy meeting with Prime Minister Pham Minh Chinh;
  - Meet Chairman Le Hoai Trung, Central Commission for External Relations; and
  - Engagement with New Zealand and Vietnamese business leaders.

- During my visit to Malaysia, we intend to travel to Kuala Lumpur to seek the following calls and undertake the following engagements:
  - Meet Minister of Foreign Affairs Mohamad bin Haji Hasan;
  - Meet Prime Minister Anwar Ibrahim and his wife Wan Azizah Wan Ismail, who I have remained in contact with for many years.
  - Breakfast with New Zealand business leaders; and
  - Engagement with the Malaysian racing sector which is a market for New Zealand bloodstock.
- During my visit to the Philippines, we intend to travel to Manila and seek the following calls and undertake the following engagements.
  - Meetings with Secretary of Foreign Affairs Enrique Manalo, and Secretary of National Defense Gilbert Teodoro;
  - Courtesy call on President Ferdinand Marcos; and
  - Reception at the Official Residence for alumni and bilateral relationship stakeholders.
- During my visit to Timor-Leste, we intend to travel to Dili and seek the following calls and undertake the following engagements:
  - Prime Minister Xanana Gusmao and Minister of Foreign Affairs and Cooperation, Bendito dos Santos Freitas;
  - A New Zealand alumni breakfast; and
  - Wreath laying at the New Zealand plaque to commemorate
     New Zealanders who died in the fight for Timor-Leste's independence.
- In Viet Nam, the Philippines and Timor-Leste we will use the opportunity of my engagements to assess the effectiveness of New Zealand's International Development Cooperation programme.
- 19 We will transit overnight in Indonesia (Bali). s6(a), s9(2)(a)
- 20 If travel is approved, we will depart for Ha Noi on Tuesday 4 June, and return to New Zealand on Thursday 13 June via Bali.
