REPORT ON TRAVEL: VISIT TO SOLOMON ISLANDS, PAPUA NEW GUINEA, VANUATU, AND TUVALU: 12–17 MAY 2024

We recommend that Cabinet note this report on travel to Solomon Islands, Papua New Guinea, Vanuatu, and Tuvalu 12 – 17 May 2024. Due to civil unrest in New Caledonia, our planned travel to Noumea had to be cancelled.

- 2. The three overarching objectives were to: 1) build New Zealand's relationship with Solomon Islands, Papua New Guinea, Vanuatu, and Tuvalu; 2) reinforce our shared focus on addressing Pacific priorities; and 3) highlight New Zealand as a key partner.
- 3. The New Zealand delegation included the Ministers of Foreign Affairs, Pacific Peoples & Health, and Climate Change; the chair of the Foreign Affairs, Defence and Trade Select Committee; the Opposition Foreign Affairs Spokesperson; and media. All seemed pleased with how the five days unfolded.

#### Visit to Solomon Islands

- 4. We travelled to Honiara 12 May en route to Papua New Guinea. We were on the ground for two hours and took the opportunity to meet newly elected Prime Minister Jeremiah Manele and members of his Cabinet. Our primary focus was to reconnect early with the incoming government. s9(2)(f)(iv)
- 5. Our meeting with PM Manele and his Cabinet was positive. PM Manele appreciated our efforts to see the new government so soon after its swearing in<sup>s6(a)</sup> s6(a)

New Zealand's recent support to Solomon Islands election was acknowledged.

- 197 Affairs We travelled to Port Moresby 12-14 May and met with: Foreign Minister 8. Tkatchenko; Deputy Prime Minister Rosso; had a courtesy call on PM Marape; visited both the Fred Hollows Eye Clinic and PNG's Green Finance Centre; and delivered a speech at the Kumul Leadership Centre. I also met with the Autonomous Proactively released by the wift

We took the opportunity to outline New Zealand's existing support, including on infrastructure, trade and economic matters, labour mobility, and climate change and energy security. While in Port Moresby we announced: an \$18.9 million contribution to the construction of a Centre of Excellence in Eye Health; a \$17 million contribution to a joint Australia-New Zealand Electricity Grid Solar Upgrade project in Bougainville; and a \$9 million contribution to supporting peace and development in the Papua New Guinea highlands. All of the Ministers with whom we discussed New Zealand's assistance reaffirmed that New Zealand's contribution was valued.

As well as our calls on counterparts, we visited the infrastructure project of South Paray wharf. An extra day in Port Vila (due to the cancelled visit to Noumea) allowed us to attend the formal Opening of the First Ordinary Sitting of Parliament for 2024.

were underpinned by warm and strong personal connections. The Prime Minister, DPM and Minister of Climate Change were consistent on Vanuatu's priority concern with climate change, and development priority on resilient infrastructure to support economic development while adapting to climate change. We visited the s6(a) development project in South Paray Wharf, which is on track for completion by 2025. Our announcement of NZ\$8 million for climate flexible finance was well received and reinforced the delegation's message that New Zealand understood the seriousness of climate impacts s6(a)

#### Cancelled visit to Noumea

Due to civil unrest in New Caledonia, our planned two-day visit to Noumea had to be cancelled. We have, subsequently, engaged extensively with both the New Caledonian authorities and the French government in the context of seeking permission to assist with the departure of New Zealanders caught up in the unrest. All who wished to depart have had the opportunity to depart.

#### Visit to Tuvalu

- For the final leg we visited Tuvalu 16 17 May. We met: Deputy Prime 18. Minister and Minister of Finance Panapasi Nelesone; Minister of Foreign Affairs, Labour, and Trade Paulson Panapa; Minister of Home Affairs, Climate Change, and Environment Dr Maina Talia; the Minister for Health, and Social Welfare Tuafafa Latasi; and attended a State Dinner hosted for us by the Government of Tuvalu.
