Report on Overseas Travel: Rt Hon Winston Peters and Hon Dr Shane Reti – Tuesday 6 February – Saturday 10 February 2024

I recommend that Cabinet note this report on my travel to Tonga, Cook Islands and Samoa from Tuesday 6 February to Saturday 10 February 2024. Minister of Health and Minister of Pacific Peoples, Hon Dr Shane Reti also joined the delegation.

Report

- This visit, to three locations in four days, successfully demonstrated the renewed commitment under the New Zealand Government to engaging with Pacific partners. The pace of engagements which included substantive meetings with political leaders, visits to local projects and receptions allowed the visits to have high impact and good profile. It was also an opportunity to reconnect with the incoming and outgoing chairs of the Pacific Islands Forum (PIF), and the host of the Commonwealth Heads of Government Meeting (CHOGM),s9(2)(g)(i) We sought to demonstrate that this government will be more present, that we will be active and respectful, good listeners and partners in the region.
- Common interests discussed across all three visits included the bilateral and development relationships, opportunities for improvement in facilitating people-to-people links, enhancing post-COVID-19 health cooperation, climate change cooperation, labour mobility, and regional relationships.
- The participation of Minister Reti brought relevant portfolio depth given the importance of health cooperation in these partnerships, but also underlined our broad, whole-of-government engagement in the Pacific. The value of New Zealand's health support, and in particular the Polynesian Health Corridors programme, was reiterated by partners. Engagements reinforced the close links with diaspora populations and highlighted the continued need to support Pacific communities in New Zealand.

Tonga

Highlights of the programme in Tonga included a roundtable meeting led by Acting Prime Minister Hon. Samiu Vaipulu and Cabinet Ministers, and the opening of the Pharmacy Warehouse, to which New Zealand had provided NZ\$2.4 million for the construction. There was also a contribution of NZ\$20 million to the programme Weather Ready Pacific. Both countries agreed to reinforce structured engagements through a refreshed Statement of Partnership and to schedule High Level Consultations. Tonga also proposed annual Ministerial-level meetings.

- The importance of PIF as the pre-eminent Pacific region mechanism was discussed. We assured Vaipulu of New Zealand's commitment to supporting Tonga as incoming Chair of the Forum and helping to ensure its success.

- On the Recognised Seasonal Employer (RSE) scheme, Vaipulu hoped to work together to address issues for workers, including accommodation, benefits and workers' rights. We noted New Zealand was trying to come up with solutions and suggested we could provide more support in training.
- 9 Regarding economic development, Vaipulu thanked New Zealand for the commitment to rebuild the Parliament building and the installation of the second ICT cable. s6(a)
- Minister Reti met separately with Tonga's Minister of Health, Dr. 'Akau'ola, who raised ambitions for Tonga National University to develop its School of Medicine, particularly in post graduate diplomas. Dr. 'Akau'ola noted the need for more nutritionists and pharmacists. He asked to formalise an arrangement to upskill emergency medicine doctors.

Cook Islands

- In Rarotonga, the visit involved a ground-breaking ceremony for a New Zealand-funded farmers and crafts market at Punanga Nui Market, meetings with Prime Minister Brown, Cabinet members, and the Leader of the Opposition. Minister Reti undertook a visit to Rarotonga Hospital. The day concluded with a Waitangi Day reception.
- Brown said our visit presented an opportunity to reaffirm economic, health, security and climate resilience as ongoing bilateral priorities. He thanked New Zealand for its support during COVID-19. Brown welcomed our announcement of an additional \$16.5 million in climate finance support, and asked that New Zealand continue its Polynesian Health Corridors and Core Sector Support programmes. Brown underlined the importance of our joint Infrastructure Trust Fund (ITF), which had funded the Punanga Nui Market.

- 13 On chairing of the PIF, Brown described it as a very successful Leaders' meeting. He underscored the significant interest in the Pacific on the part of dialogue partners.

Regarding the Cook Islands' proposed trilateral security agreement, Brown told media that Rarotonga was looking for more of an expansion of the existing arrangements in place, including as they relate to defence, transnational crime, and cyber, air and maritime security.

Samoa

- Ster of Foreil In Samoa, we met with the Head of State (O le Ao o le Malo), the 17 Prime Minister Fiame Naomi Mata'afa, and the Leader of the Opposition Tuila'epa. The delegation also attended a Waitangi Day reception, and announced new IDC funding for the South Pacific Regional Environment Programme (SPREP). New funding was also announced during a visit to the National University of Samoa for the Batchelor of Health Science programme, and for the second phase of the Polynesian Health Corridors programme.
- 18 Both countries signed a renewed Statement of Partnership 2024-2028 which was updated to acknowledge new priorities including the Pathway for the Development of Samoa, CHOGM 2024 and our Climate Finance Partnership.
