Government Response to the Petition of Mohamed Soliman on Closing the Israeli Embassy in New Zealand

Government response to the petition of Mohamed Soliman on Closing the Israeli Embassy in New Zealand

Purpose

This paper seeks approval of the government's response to the Petitions Committee referral of the petition entitled *Mohamed Soliman: Close the Israeli Embassy in New Zealand.*

Background

- On 4 March 2024, the Petitions Committee referred the petition of Mohamed Soliman to the Minister of Foreign Affairs for response under the Standing Order 380.
- The petition requests that the New Zealand Government limit the diplomatic relationship between New Zealand and Israel by closing the Israeli Embassy in New Zealand.
- The Israeli Embassy in Wellington originally opened in 1975 and closed for three years between 2002 and 2005. The New Zealand Embassy in Ankara, Türkiye is accredited to Israel. s6(b)(i)

- Since the 7 October 2023 Hamas terrorist attacks on Israel and consequent Israeli military offensive in Gaza, there has been renewed public interest in the broader Israeli-Palestinian conflict. Protests, community engagement, and anti-social or illegal behaviour related to the issues has increased in New Zealand as a result. This has included acts of vandalism committed against the Israeli Embassy in Wellington and a reported rise in antisemitism. There have also been increased political calls for action to address the perceived injustices facing Palestinians and Israelis, including as relates to New Zealand's relationships with other countries.

Comment on the government response

7 The Minister of Foreign Affairs recommends the government not respond positively on the petitioner's request that "the New Zealand Government limit the diplomatic relationship between New Zealand and Israel by closing the Israeli Embassy in New Zealand." As the government response lays out, it is

not in New Zealand's interest to restrict diplomatic channels that enable bilateral discussions on issues of importance to New Zealand ^{s6(a)}

This is especially relevant where New

Zealand is geographically distant from the country in question, as is the case with Israel.

- Dialogue and an ability to freely exchange frank views are the lifeblood of international relations. The government response lays out how the Israeli Embassy's presence has allowed the government to act in New Zealand's interests recently, including:
 - 8.1 To express our condolences for the victims of the 7 October 2023 Hamas terrorist attacks on Israel;
 - 8.2 To request Israel's support for New Zealand consular efforts in Israel and the evacuation of New Zealand citizens and permanent residents from Gaza; and
 - 8.3 To register New Zealand's deep concerns regarding the on-going conflict in Gaza and the broader situation in the region.
- The government response also notes the potential detrimental consequences if the government were to seek to close the Israeli Embassy. If we expelled Israeli Embassy staff and effectively closed the Embassy, we would expect Israel to respond in kind.
- 10 New Zealand officials have met with the Israeli Ambassador ^{s6(a)} since the 7 October terrorist attack. ^{s6(a)}

11 The government response must be presented to the House by 28 May 2024.
