Government Response to Petition of Peter James Cullinane

Portfolio Foreign Affairs

On 8 August 2024, the Cabinet Legislation Committee:

- noted that on 30 April 2024, the petition entitled "Peter James Cullinane: Support for criminal investigations into crimes committed in Gaza and West Bank" (the Petition) was presented to the Petitions Committee;
- **noted** that on 24 May 2024, the Petition was referred to the Minister of Foreign Affairs for response;
- noted that the proposed response to the Petitioner makes clear that the New Zealand Government has already taken actions to put additional pressure on Israel to end the conflicts in Gaza and the West Bank, by supporting criminal liability proceedings for violations of international law and human rights committed by either side;
- **approved** the Government response to the Petition, attached to the paper under LEG-24-SUB-0152;
- 5 **noted** that the Government response will be presented to the House by 19 August 2024;
- **invited** the Minister of Foreign Affairs to present the Government response to the House in accordance with Standing Order 380;

Government response to the petition of Peter James Cullinane: Support for criminal investigations into crimes committed in Gaza and West Bank

Purpose

This paper seeks approval of the Government's response to the Petitions Committee referral of the petition entitled "Peter James Cullinane: Support for criminal investigations into crimes committed in Gaza and West Bank."

Background

- On 24 May 2024, the Petitions Committee referred the petition of Peter James Cullinane to the Minister of Foreign Affairs for response under Standing Order 380.
- The petition, signed by 42 people, requests that the New Zealand Government put additional pressure on Israel to end the conflicts in Gaza and the West Bank, by supporting criminal liability proceedings for violations of international law and human rights committed by either side.
- A written submission in support of the petition sets out the need for New Zealand to support international institutions including the United Nations, the International Court of Justice (ICJ) and the International Criminal Court (ICC), and notes that the fact that some nations do not recognise the jurisdiction of these courts makes it more incumbent on other nations to support them.
- The written submission asks the Government to publicly announce its support for investigations by the ICJ and ICC into potential war crimes and violations of human rights in Gaza and the West Bank committed by either side. It specifically notes that the Government is not being asked to adjudicate or judge alleged war crimes as those judgements should be left to international judicial bodies.

Comment on the Government response

Accordingly, the Minister of Foreign Affairs recommends the Government makes clear to the petitioner that the New Zealand Government has already taken actions to put additional pressure on Israel to end the conflicts in Gaza and the West Bank, by supporting the institutions that conduct proceedings for violations of international law and human rights committed by either side, and by setting out the positions and actions New Zealand is taking in this regard.

- 7 The response to the petition notes that adherence to international law and support for the rules-based international system has underpinned New Zealand's approach to the conflict in Gaza.
- The response also outlines New Zealand's positions in relation to international law as applied to all sides of the conflict in Gaza, as well as New Zealand's support for the ICJ and the ICC.
- It points the petitioner to New Zealand's positions in South Africa's case at the ICJ accusing Israel of genocide, where New Zealand has supported the binding nature of the ICJ's provisional measures requiring Israel to halt its military offensive in Rafah; take all necessary measures to provide basic services and humanitarian assistance and abide by obligations under the Genocide convention and international humanitarian law.
- It also points the petitioner to New Zealand's positions in relation to the ICC's ongoing investigation into the Situation in Palestine, where New Zealand has supported the ICC's independent and impartial mandate.
- The response also refers the petitioner to the numerous speeches and National Statements made by New Zealand in international institutions on the conflict between Israel and Hamas, and New Zealand's strong and continued engagement in international institutions such as the United Nations, the ICJ, and the ICC.
- On 20 May 2024, after this petition was lodged, the ICC Prosecutor applied for warrants of arrest against Hamas leaders Yahya Sinwar, Mohammed Deif, Ismail Haniyeh; and against Israeli Prime Minister Benjamin Netanyahu and Minister of Defence Yoav Gallant. The judges of the Pre-Trial Chamber of the ICC are currently deciding whether to issue the requested warrants. New Zealand has responded to the warrant request by reaffirming support for the ICC and its mandate while declining to comment on the request until a decision has been made.

Timing of the government response

The Government response must be presented to the House by 19 August 2024.
