## Report on Overseas Travel: Hon Todd McClay - April 2024

I recommend that Cabinet note this report on my travel to China from 13 April to 19 April 2024 in my capacity as Minister for Trade, Minister of Agriculture, and Minister of Forestry. The purpose of this trip was: to support New Zealand exporters to thrive in our largest offshore market; to promote primary sector trade as an area where New Zealand and China's interests converge; to underscore the importance of intellectual property rights and of positive cooperation in this area; s6(a)

## Report

1 In Beijing I had a busy programme of political meetings with Minister of Commerce, Wang Wentao; Minister of Agriculture and Rural Affairs, Tang Renjian; and, Administrator of the National Forestry and Grasslands Administration, Guan Zhi'ou Further paragraphs should discuss other significant events and/or key meetings attended, and the key achievements and outcomes of each.

2 Building on my first bilateral with China's Commerce Minister at the World Trade Organisation Ministerial meeting in Abu Dhabi (WTO MC13), I had direct but positive discussions with Minister Wang Wentao, including on China's requests for New Zealand to support its accessions to CPTPP and DEPA. I established strong initial connections with my agriculture and forestry portfolio counterparts identifying many areas of increased collaboration and trade

3 In Harbin I visited three sites: Grand Farm meat processing, Sayyas Windows, and DEWO Agritech, these gave a sense of developments in China's food processing, agriculture and forestry sectors and opportunities for New Zealand's primary sector exporters. I also meet with the Governor of Heilongjiang province, Liang Huiling where we discussed the growing use of technology in agriculture, energy sustainability, and the further agriculture, forestry, and education cooperation possible between New Zealand and Heilongjiang.

4 My business-focused programme in Shanghai centred around three themes: promoting New Zealand business, gaining insights from China-based business leaders, and affirming the government-to-government connection with Shanghai city.

5 I was able to promote New Zealand business and gain insights from those operating in Shanghai through several partnership events and business receptions that brought together key New Zealand and Chinese partners. My visits to Silverfern Farms, and VX Logistics facilities allowed me to highlight New Zealand's red meat and horticulture industries; and my discussion with members of Primary Collaboration New Zealand included the value of localised branding, non-tariff barriers (NTBs), and the impact of China's changing demographics on New Zealand trade.

6 In my meeting with Shanghai Mayor, Gong Zheng we discussed issues in Shanghai's business environment for New Zealand businesses, increased New Zealand business investment into Shanghai, \$\frac{s9(2)(f)(iv)}{2}\$

7 The visit provided a valuable and positive opportunity to signal that the Government remains committed to growing bilateral trade relations with China, which is part of our broader strategy of trade diversification and of doubling exports by value in 10 years. <sup>s6(a)</sup>
