Thank you for your email of 8 January 2025 in which you request the following under the Official Information Act 1982 (OIA):

for any documents, emails or correspondence between MFAT, the Minister of Foreign Affairs and Trade, the Transport Minister and the Cook Islands government over the past five years relating to the establishment and operation of a Cook Island shipping registry.

On 25 January 2025 you agreed to refine the scope of your request to be for:

1. Submissions to a Minister that outline New Zealand's policy position relating to the establishment and operation of a Cook Island shipping registry, 1 Jan 2020 – 1 Jan 2025

2. Formal reporting relating to the establishment and operation of a Cook Island shipping registry, 1 July 2024 to 8 January 2025

On 24 February 2025, the timeframes for responding to your request were extended by an additional 25 working days because responding to your request necessitated the review of a large quantity of information, and due to the consultations necessary to make a decision on your request (section 15A(1)(a) and (b) of the OIA refers).

The Ministry of Foreign Affairs and Trade (the Ministry) has not provided any submissions to a Minister that outline New Zealand's policy position relating to the establishment and operation of a Cook Island shipping registry, 1 Jan 2020 – 1 Jan 2025. Therefore, this part of your request is refused under section 18(e) of the OIA as the information requested does not exist.

20. We shared an update on New Zealand's latest tranche of sanctions against Russia. We emphasised our deep concerns about Russian and DPRK's use of dark fleet vessels to transport oil in contravention of the G7+ Oil Price Cap, and in breach of likeminded partners' sanctions regime. We underlined our concerns regarding the Cook Islands registry registering vessels associated with the shadow fleet, and undertook to provide information soon on Cook Islands-flagged vessels we suspect were doing dark fleet activities [Comment: This was since provided to MFAI on 6 Dec].

- [9(2)(g)(ii)] opened a discussion on the dark fleet, which she noted was a good example
 of the more contested space we find ourselves in. [9(2)(g)(ii)] began by providing an
 update on the recent tranche of New Zealand sanctions against Russia, which are aimed
 at individuals connected to chemical weapons and ballistic missiles. New Zealand had now
 sanctioned over 700 individual and entities.
- [9(2)(g)(ii)] noted that New Zealand remained deeply concerned about Russian and DPRK's use of 'shadow fleet' vessels to transport oil in contravention of the G7+ Oil Price Cap and like-minded partners sanction regime. These vessels present a global threat, undermining sanctions and risking the environment. They are old, often poorly maintained, under-insured and do not meet international standards.
- [9(2)(g)(ii)] acknowledged the Cook Island's request for a list of vessels of concern, which was being collated by New Zealand's Maritime Coord nation Centre and would be shared soon. [9(2)(g)(ii)] noted that once the list was shared MFAT would welcome further discussion. [9(2)(g)(ii)] also acknowledged the interest of likeminded partners on this issue, and shared that Foreign Minister Peter was currently in London in a meeting with counterparts, and that we have announced our joining the international "call to action" against the Shadow fleet, alongside Australia and Japan. MFAT was keen to continue to share information to support the Cook Islands.
- Upon prompting about these 'dark fleet' vessels, [9(2)(g)(ii)] explained that the dark fleet
 were normally oil tankers, aptly named due to 'going dark' by turning off trackers to
 obfuscate their movements. This makes it very tricky to monitor as one has to line up
 satellite data with the tracker information. The complex ownership of these ships means
 that shipping registries have to be very well equipped to monitor and have good due
 diligence processes in place for registering vessels.
- [9(2)(g)(ii)] commented that the dark fleet undermines our efforts to make the world less
 contested and that it was very unfortunate that many of the fleet were Cook Islands'
 flagged vessels.

RAPOPOTO – SUMMARY

- almornation We remain concerned that the Cook Islands Shipping Registry (the Registry) is associated with the "dark fleet". We are aware of increased media reporting on the scale of the issue and that likeminded partners have sanctioned vessels that are flagged by the Registry.
- We would appreciate RRO registering our concerns with the Cook Islands' Foreign Affairs Ministry (MFAI), in addition to the Ministry of Transport (MoT), to ensure there is awareness of the associated risks to the Cook Islands' reputation, international relations, and potential legal and financial liability.
- New Zealand is considering joining the "The Shadow Fleet: A Call to Action" (LON FM of 4 October refers), subject to approvals, by late November. As part of RRO's engagement on this issue, we would appreciate your informing MFAI of our intention to join the Call to Action.
- We are keen to support the Cook Islands in managing this issue. We would appreciate RRO's further investigation using the provided key messages, and subsequent reporting to inform New Zealand's response and level of support. Relevant NZ Inc agencies are exploring ways New Zealand can support, and s6(a), s7(b)(i), s7(b)(ii)

HOHENGA – ACTION

- **RRO**: grateful if Post formally raises with the MFAI (alongside MoT if useful) the actions of Cook Islands' flagged vessels using the key messages provided; offer further technical assistance to support the Cook Islands in managing this problem; and advise the Cook Islands of New Zealand's intention to join the Call for Action.
- **EUR/LON**: for information only at this stage, in response to earlier FMs relating to the UK's suggestion for New Zealand to join the Call to Action.

PŪRONGO – REPORT

1. We appreciate RRO's FM detailing ${}^{s7(b)(i), s7(b)(ii)}$

amid recent reports that Cook Islands' flagged vessels are operating as part of the "shadow fleet" or "dark fleet", which is functioning in breach of International Maritime Organization (IMO) standards and other international norms.

We ask that RRO emphasise the seriousness of the situation from an international relations, international security, potential liability, and reputational perspective. The actions of Cook Islands' flagged vessels, and any perceptions of lack of action or concern by the Cook Islands Government in response, could affect the Cook Islands' international standing, and the efficacy of international sanctions efforts of like-minded countries. You should also make the point that the activities of dark fleet vessels directly undermine international security, and therefore our shared security interests.

4. In the course of this discussion, we should also impress upon the Cook Islands the seriousness with which New Zealand and other partners take the "shadow or dark fleet", and draw their attention to "The Shadow Fleet "<u>Call to</u> <u>Action</u>". You should advise the Cook Islands that as it aligns with New Zealand's policy positions, we are intending to join the "Call to Action".

Financial and legal risk exposure for the Cook Islands (and New Zealand)

5. In addition to the identified risks to their international security and reputation, any dark fleet vessels flagged by the Registry pose significant financial and legal risk to the Cook Islands. The dark fleet often acts in illegal and unsafe ways (as shown by the <u>recently reported</u> fire onboard a Cook Islands' flagged vessel off the coast of Bangladesh). Dark fleet vessels are often under-insured. If a Cook Islands' flagged vessel was involved in a maritime incident and was under-insured, injured States may seek to hold the Cook Islands responsible for the costs of salvage or compensation for damage.

6. We wish to understand whether the Cook Islands has considered these scenarios, and what steps have been put in place to mitigate risk. ${}_{(i)}^{s7(b)(i), s7(b)}$

The UK recently announced on 17

October, sanctions on an additional 22 vessels (of which four are Cook Islandsflagged vessels). This brings it to a total of nine Cook Islands-flagged vessels that have so far been sanctioned under the UK Russia sanctions regime, out of 59 vessels that have been sanctioned to date.

New Zealand technical support for the Cook Islands: Is there more we can do?

10. New Zealand has in the past supported work to strengthen governance and capability in the Cook Islands Mot through the "Strengthening Pacific Shipping" Registries" programme (with Corio Bay Consultants) and Maritime NZ's port security and maritime safety programme. This included an in-person audit of the Registry by Corio Bay last year, and supporting capacity and capability development of Cook Islands fisheries officers through the MPI-run programme Te Patui. All these activities are funded through the IDC or the Pacific Security Fund.

We wish to know what support the Cook Islands might find useful from 11. New Zealand to respond to this issue and, more generally, improve its Shipping Registry. s7(b)(i), s7(b)(ii)

RRO's reporting on this issue will support relevant NZ Inc agencies' efforts to explore ways New Zealand can provide support, ^{s7(b)(i), s7(b)(ii)}

Key messages

- Note New Zealand's concerns following the increased media reporting on the Cook Islands Shipping Registry containing vessels associated with the "dark fleet".
- Refer to the UK's latest sanctions against the "dark fleet" which included 22 vessels. Note that we understand that four of those vessels were flagged by the Cook Islands. [If required, given MFAI may not be aware of the "dark fleet" - see background section].

- Underline the impact of the Cook Islands Shipping Registry being associated with the "dark fleet" has on -
 - <u>Cook Islands' international reputation, and relations</u> if the Cook Islands is perceived as not acting quickly to remedy the situation e.g. work with MCI to de-register vessels, their international standing could be affected especially if seen to be undermining the efficacy of international sanctions efforts of like-minded countries.
 - <u>Cook Islands' international security and the potential liability</u> if a serious incident were to occur to one of its flagged vessels e.g. dark fleet vessels are often under-insure, injured States may seek to hold the Cook Islands responsible for the costs of salvage or compensation for damage.

- Seek to understand whether the Cook Islands has considered the above scenarios and implications. Ask about steps taken to mitigate the above risks.
- Note that New Zealand remains ready to support wider efforts the Cook Islands might be considering in strengthening its Shipping Registry, as we have in the past through Corio Bay.
- Seek more information about how New Zealand can support immediately e.g. expertise or intelligence to help the Cook Islands' response – as well as any long-term ideas or efforts.
- Note that we have been approached by partners to join the "<u>Call to Action</u> on the Shadow Fleet". In line with New Zealand's policy positions, share that we are intending to join the Call to Action. [<u>If required</u>, briefly explain the "Call to Action" using background info below].

Background

What is a Dark fleet vessel and why do they pose a risk?

- Shadow fleet or dark fleet vessels are operating inconsistent with international norms and standards – with direct implications for our environment, maritime safety and security, the integrity of international seaborne trade, respect for international maritime law. They undermine international efforts to up-hold the UN Charter through sanctions, regarding Iran, Russia, and wider nonproliferation efforts.
- According to Lloyds list methodology, a tanker vessel is defined as being part of the "dark fleet" when it is aged 15 years or over, anonymously owned and/or has a corporate structure designed to hide its beneficial ownership and is solely deployed in sanction oils trades.
- "Dark or shadow" refers to the practice when tanker vessels are observed switching off their vessel tracking transponders to avoid detection and hide the origin and destination of the goods they are carrying.
- The dark fleet is understood to encompass hundreds of tanker vessels that

employ varying degrees of illicit or evasive tactics. The worst of dark fleet characteristics could include fraudulent representations of class and insurance, alongside a history of "flag hopping" and voyage irregularities such as turning off tracking transponders.

- Ownership and technical management of these vessels can be unknown and is often overtly complex - and activities can sometime include taking on cargoes via ship-to-ship transfers in international waters.
- Dark fleet vessels can carry as much as 100,000 tonnes of crude oil.
