Thank you for your email of 1 March 2025 in which you request the following under the Official Information Act 1982 (OIA):

"Under the Official Information Act, please supply a list of all formal briefings sent to the Minister of Foreign Affairs by the Ministry of Foreign Affairs and Trade between 1-28 February 2025."

Between 1 and 28 February 2025, the Ministry of Foreign Affairs and Trade provided 56 briefings to the Minister of Foreign Affairs. These are attached in **Annex One**. 16 briefing titles are withheld under the following sections of the OIA:

- 6(a): to avoid prejudicing the security or defence of New Zealand, or the international relations of the New Zealand Government;
- 6(b)(i): to protect the passing of information from another government on a confidential basis;
- 9(2)(b)(i): protect information where the making available of the information would disclose a trade secret;
- 9(2)(d): to protect the economic interests of New Zealand;
- 9(2)(f)(iv): to protect the confidentiality of advice tendered by Ministers of the Crown and officials;
- 9(2)(g)(i): to protect the free and frank expression of opinions by departments;
   and
- 9(2)(j): to avoid prejudice to negotiations.

Where the information has been withheld under section 9 of the OIA, no public interest in releasing the information has been identified that would override the reasons for withholding it.
