## **Russia Sanctions Amendment Regulations (No 5) 2024**

#### Proposal

This paper seeks authorisation for submission to the Executive Council of the Russia 1 Sanctions Amendment Regulations (No 5) 2024 (the Regulations).

#### Policy

- 2 The Minister of Foreign Affairs is the Responsible Minister under the Russia Sanctions Act 2022 (the Act), and therefore has discretion to decide whether to recommend that sanctions regulations be made under the Act.
- 3 s6(a)
- The regulations will implement sanctions measures under the Act, designating 4 individuals and entities providing material and/or strategic support for Russia's illegal invasion of Ukraine, with regard to the deployment of chemical weapons or the facilitation of Iranian military assistance.

# Release Timing and 28-day rule

s6(a), s9(2)(g)(i) 5

### Compliance

- The regulations are in line with the intent and purpose of the Act, and comply with 6 each of the following:
  - 6.1
- the principles of the Treaty of Waitangi;
- 6.2 the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 or the Human Rights Act 1993;
- 6.3 the principles and guidelines set out in the Privacy Act 2020;
- 6.4 relevant international standards and obligations;

- 6.5 the Legislation Guidelines (2021 edition), which are maintained by the Legislation Design and Advisory Committee.
- 7 Section 8 of the Act sets out a threshold which the responsible Minister must be satisfied has been met before recommending that an Order in Council be made with regard to sanctions under section 9 of the Act. The Section 8 threshold is that: (i) the regulations are appropriate to respond to threats to the sovereignty or territorial integrity of Ukraine or another country; and (ii) the United Nations Security Council is unlikely to act or has acted insufficiently.
- 8 The Minister is satisfied that the threshold in section 8 has been met for the sanctions measures in the recommended regulations, including with regard to the designation of each individual and entity as identified in Annex 1 of the submission to the Minister of 22 October 2024, entitled Russia Sanctions - Tranche 29.

9 There are no grounds for the Regulations Review Committee to draw the regulations to the attention of the House of Representatives under Standing Order 327.

#### **Certification by Parliamentary Counsel**

The draft regulations were certified by the Parliamentary Counsel Office as being in 10 order for submission to Cabinet.

#### Consultation

14 The Ministry of Foreign Affairs and Trade has consulted the following agencies in the developing the draft regulations: Parliamentary Counsel Office, New Zealand Police, Land Information New Zealand, Customs, Immigration, the Reserve Bank, the Financial Markets Authority, and Transport.

#### **Recommendations**

The Minister of Foreign Affairs recommend that the Cabinet Legislation Committee:
