Portfolio Trade

On 9 December 2024, Cabinet:

- authorised the absence of Hon Todd McClay from New Zealand, from 22 to 26 January 2025, to travel to Zurich, Switzerland to attend a meeting of the World Trade Organization (WTO) Ministers;

Proposed Overseas Travel: Hon Todd McClay - January 2025

- I seek Cabinet approval to travel to Zurich, Switzerland from Wednesday 22 January to Sunday, 26 January 2025, in my capacity as Minister for Trade to attend a meeting of the World Trade Organization (WTO) Ministers.
- The Chief of Staff has approved the travel in-principle, and leave has been sought from the Party Whip.

Purpose of Travel

- I propose to participate in the annual Swiss-hosted Ministerial meeting of World Trade Organization (WTO) Ministers. The WTO is a cornerstone of New Zealand trade policy as it deals with the global rules of trade.
- This Swiss-hosted meeting is a small gathering of the prominent players on WTO matters (roughly 20 of over 160 members). Attendance is by invitation only and my participation would reflect New Zealand's active voice in ongoing negotiations on issues important to us and our Pacific region, including on agriculture and fisheries subsidies.
- The meeting will serve as an opportunity for political engagement in the build up to the next WTO Ministerial Conference (scheduled for March 2026).

I will be accompanied by officials from the Ministry of Foreign Affairs and Trade (MFAT). All costs for MFAT staff will be covered from within the Ministry's baseline budget.
