PROPOSED OVERSEAS TRAVEL OF UNDER-SECRETARY FLETCHER TABUTEAU: NAURU, 29 JANUARY – 1 FEBRUARY 2019

I seek Cabinet approval to travel to Nauru from 29 January – 1 February 2019 for the closing ceremony of 50th independence celebrations. The Prime Minister has given in principle approval for this travel.

Visit Objectives

2 The objective for my visit is to reinforce the bilateral relationship, as part of a broader plan (approved by the Minister of Foreign Affairs) to expand New Zealand's engagement with Nauru. During my visit I will, in particular, engage with Nauru on good governance, human rights, and greater economic and political empowerment.

Travel

3 I propose to depart New Zealand on the afternoon of Tuesday 29 January and return to New Zealand on the evening of Friday 1 February 2019.

Travelling Party

4 I propose to be accompanied by a Foreign Affairs Private Secretary based in the Office of the Minister of Foreign Affairs.

Under-Secretary Responsibilities

5 If the travel is approved, I propose that the Minister of Foreign Affairs cover my Foreign Affairs responsibilities and that the Minister for Regional Economic Development cover my Regional Economic Development responsibilities.

Costs of Travel

6 The projected costs of the proposed travel for the travelling party are:

Contingency (5%):	\$1,000
Hospitality and gifts:	\$500
Accommodation and other expenses:	\$2,500
Airfares:	\$6,000

 - b) note that I would be accompanied by one staff member from the office of the Minister of Foreign Affairs;
 - approve expenditure up to \$10,000 for the travel expenses of the travelling party as a charge to Vote Internal Affairs: Members of the Executive – Travel; and
 - d) **agree** that my Foreign Affairs responsibilities be covered by the Minister of Foreign Affairs from 29 January to 1 February 2019;
 - e) agree that my Regional Economic Development responsibilities be covered by the Minister for Regional Economic Development from 29 January to 1 February 2019;

REPORT ON OVERSEAS TRAVEL: NAURU: 29 JANUARY – 1 FEBRUARY 2019

It is recommended that Cabinet note this report on travel by the Under Secretary of Foreign Affairs to Nauru from 29 January -1 February 2019.

Report

2 I travelled to Nauru to attend the closing ceremony of 50th independence celebrations. The objective for my visit was to reinforce the bilateral relationship, as part of a broader plan to expand New Zealand's engagement with Nauru.

3 The small number of delegations that attended the ceremony highlighted New Zealand's presence. Among Pacific Island countries, only Republic of Marshall Islands attended at head of state level with HE Hilda Heine leading the delegation. Australia sent Assistant Minister Anne Ruston, which offered me a valuable opportunity to meet the Senator for the first time and to informally discuss a range of issues.

4 I had a bilateral meeting with President Waqa after the closing ceremony, at which I congratulated the President on 51 years of Independence. The President noted with pride that over 1000 people have visited Nauru over the past year to take part in various celebrations and events. The President also noted that New Zealand is "back and bigger", and that showing up to these celebrations was an indication of a stronger relationship. 5 The President inquired about Minister Peters and stated that the Minister has enabled Nauru to start feeling more comfortable with New Zealand. The President went on to note the positive impact of the Pacific Reset, which he summarised as being about supporting Pacific people to be more confident with themselves. The President also emphasised that the Pacific Reset is an "excellent approach" and that while New Zealand has always been there, there needs to be a stronger relationship.

6 During the meeting I raised Minister Peters' announcement of an increase in New Zealand's development budget to Nauru by \$8 million. I also referenced the previous days' Aid Talks between officials, which focused on how New Zealand might best support Nauru's economic resilience and governance goals.
